Hello Ms Marais

I wish to advise you, that despite being a resident of Beethoven Ave, we did not receive any information about the proposed development of the Walmer Gqebera Housing project on erf 11305.

The first we heard about it was through the freebie newspaper which ran an article. As residents of the suburb of Walmer Heights, and more importantly of Beethoven Ave which is going to be closest to this development, my husband and I wish to submit my strongest objection to this.

I believe too that even those who did receive notification, were only given 3 days to offer comment - which I am sure is inadequate by any standards.

We have lived in Walmer Heights for 18 years, and it has steadily become a busier suburb with the advent of new housing complexes and estates. With only 3 access roads into the area, increasing traffic levels have been seen over the years. Therefore I feel that by allowing access to the new proposed development, esp through Beethoven Ave will increase traffic flow substantially and congest the area even further. Not only will it congest the roads in Walmer Heights but also down Buffelsfontein road, into Heugh Rd, as well as William Moffett. As these roads already carry excess traffic and have difficulty coping, please explain to all of us how these routes will cope with more than 10 000 people living in the area.

Walmer Heights is a relatively quiet and safe suburb, and one occupied by many young families with young children. Currently it is still safe for them to play outside, in the park, ride their bikes in the street etc.

This, however, will change with a low cost housing development in the immediate vicinity. With busier streets, it will no longer be safe for them to play outside. As it is we already have people talking short cuts through the suburb from Walmer location to their place of work - this will escalate substantially with 1400 houses being built in the vicinity.


We have seen the depreciation of properties in Walmer which are near the location, and as we have spent considerable amounts of money on improving our properties, we don't want to see our huge investments lost, and out

properties devalued. Nor do we wish to spend any more money on security than we already have.

Three to four times a year we are subjected to violent protests by Walmer location residents who blockade roads, burn tyres etc. This is obviously an absolute no-no for residents of a peaceful suburb. Apart from being law abiding citizens I would like to see my tax money spent on upgrading areas, not constantly fixing burnt roads and vandalized buildings

There will be an increase in drug trafficking and alcohol abuse due to the no of shebeens and taverns in these regions - again increasing the risk for

IU received a copy of a petition to ask for a reversal of Building Permission granted for low cost housing in the Walmer Country club area.

Having read it, I agree with most of the points, some of which could be classified as generalizations and even racist – but probably true nevertheless. The real argument is "Not in my back yard". Again I am sympathetic. But one must realize the reality of the situation, this government depends on the votes of those who will get these houses, we can not deny there is a housing shortage (really the problem is that there are just too many people in the world and in South Africa – but that is for solving at a different time) so just opposing the building is not likely to succeed. A point that should be arguable is the approach. When Walmer Heights was first built it was a small area serviced by Titan and Sibelius, which were adequate for the job. The area is a truly residential one. Since its start Sibelius has been made a through road and now the intention is to route access to these new houses through Walmer Heights. The roads were never designed for that, initially there will be very heavy construction vehicles and eventually private cars using a service road as a thoroughfare. The logical access road should come from Victoria Road, it is more convenient to the intended inhabitants, a shorter route; so it would not be a political battle to change the access on practical grounds.

You will have my general support by I suggest you target issues.
