NOTICE OF APPLICATION FOR ENVIRONMENTAL AND WATER USE AUTHORISATION

Lapha kukhishwa isaziso sokuthi uMasipala weTheku ufaka isicelo sokugunyazwa Kwezemvelo ngokuhlolola okuyisisekelo kuMnyango Wezokuthuthukiswa Komnotho, Ezokuvakasha kanye Nezemvelo (EDTEA) ngokwemibandela YoMthetho Kazwelone Wokupathwa Kwezemvelo, uMthetho onguNo.107 ka 1998 njengalokhu uchitshiyelwe (i-NEMA). Kuyophinda futhi kufakwe isicelo Sokugunyazwa Kokusetshenziswa Kwamanzi ngokwemibandela Yesigaba 40 soMthetho Wamanzi Kazwelone, uMthetho onguNo.36 ka 1998 (i-NWA) Department of Water and Sanitation (DWS). Abanentshisekelo kanye Nabathintekayo bayamenya ukuthi babhalise ne-EnviroPro zingakapheli izinsuku ezingama-60 kusukela kukhishwe lesi saziso ukuze bathole olunye ulwazi olwengeziwe.

Notice is hereby given that the eThekwini Municipality is lodging an application for Environmental Authorisation through a Basic Assessment with the KZN Department of Economic Development, Tourism and Environmental Affairs (EDTEA) in terms of the National Environmental Management, Act No.107 of 1998 as amended (NEMA). A Water Use Authorisation application in terms of section 40 of the National Water Act, No.36 of 1998 (NWA) will also be lodged with the Department of Water and Sanitation (DWS). All Interested and Affected Parties (I&APs) are invited to register with EnviroPro within 60 days of the date of this notice for further information.

Cotton Lands Housing Development: 29°35'20.64"S 31° 3'19.72"E.



Imininingwane ngeprojekthi UMasipala weTheku uhlongoza ukuchubeka wakhe izindlu zesibonelelo eCotton Lands. Ukugunyazwa Kwezemvelo kuyadingeka ukuze kususwe u1 hektha wezithalo zendabuko ezisesimweni esisengozini enku, i-Interior North Coast Grasslands, ebhalwe ngokoMthetho Kazwelone Wokulawula Kwezemvelo: Biodiversity Act (Umthetho Nombolo 10 ka 2004). Kungahle kube nesidingo sokwakha ipayi lokuhambisa indle elisha ngokwedlula i-1km Ukuze kuhlinzekwe ngezildu zangasese ezisesimwenu esifanele. Imisebenzi eminingana yokwakha izokwenzeka futhi ngaphakathi nangaphandle kwendawo egeleza wamanzi. Ukugunyazwa Kokusebenzia kwamanzi kuyadingeka futhi ngokuya ngeSigaba 21 c & i se-NWA yanoma imuphi umsebenzi ozoguqula imibhede, amabhange, kanye nokugeleza komthombo wamanzi kufaka phakathi kwendawo elawulwayo i.e. 500m yendawo enamanzi.

Project Details: The eThekwini Municipality proposes to construct the *in-situ* Cotton Lands Housing Development. Environmental Authorisation is required for the clearance of more than 1ha of indigenous vegetation this clearance will also take place within a critically endangered ecosystem, Interior North Coast Grasslands, listed in terms of the National Environmental Management Act: Biodiversity Act (Act No. 10 of 2004). In order to provided sanitation, there may also be the requirement to construct a new bulk sewer pipeline in excess of 1km. A number of constructions activities will also take place within and in close proximity to a watercourse. A Water Use Authorisation is also required in terms of Section 21 c & i of the NWA for any activity that will alter the beds, banks, and flow of a watercourse including within the regulated area i.e. 500m of a wetland.
