NOTICE OF AN ENVIRONMENTAL IMPACT ASSESSMENT FOR THE PROPOSED DEVELOPMENT OF A RESIDENTIAL TOWNSHIP ON PORTION 437 AND PORTION 502 OF THE FARM ROOSBOOM 1102GS (LADYSMITH KWAZULU NATAL)

Notice is given in terms of Section 24 (1A)(c) of the National Environmental Management Act (Act No. 107 of 1998) and Government Notice No. R (326) that the Alfred Duma Local Municipality intends to apply for authorisation to the Province of KwaZulu Natal - Department of Economic Development, Tourism and Environmental Affairs (EDTEA).

The proposed development includes the construction of approximately 1000 residential units along with relevant supplementary land uses and services on an area of ±85ha of land currently zoned as agricultural land located approximately 10km south of the town Ladysmith in KZN. The site lies approximately 750m west of the R103 (Ladysmith/Colenso) Road and immediately south and adjacent to the existing township of Roosboom.

The applicant also intends applying for a water use license in terms of Section 21 of the National Water Act (36/1998) for the alteration of the bed or banks of a water course, impeding the low of water in a water course, developing infrastructure within 500m of a wetland and/or any other relevant water use in aid of the construction and operation of the residential township.
