## Environmental Authorisation Application for the ARMMDW – Basic Assessment Report for Proposed MnSO4 Processing Plant at ARM Machadodorp Works

ARM Machadodorp Works (ARM MDW) has been operating before under a 2011 Atmospheric Emissions Licence (AEL), which were reviewed by the Nkangala District Municipality (Licensing Authority) and issued on 28 June 2019 under Ref 17/04/AEL/MP314/11/01. Although the operation has initiated temporary cessation, the investigations in identifying more suitable, practical, and economically viable options for the running of the operation have not ceased. It is the aim of the operation to ensure that optimal production can continue in the future and that employment opportunities can be reinvested in. Current studies have raised the potential for an alternative technology to the current process used by the Furnaces. As part of the process an Atmospheric Emission Impact Assessment will be conducted by EScience (the appointed specialist).

The application for the Environmental Authorisation Process was submitted to the DARDLEA on 5 June 2023 however acknowledged by the Competent Authority has not as yet been received. In the interim the Department relocated offices and requested the EAP to resubmit the application during a telephonic follow upon 5 July 2023. The DARDLEA provided the new address on 13 July 2023 and the application was resubmitted on 14 July 2023.

It should be noted that a formal application will be lodged with the Nkangala District Municipality for the AEL, once the outcomes of this BAR Process have been finalised.
