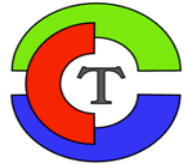

**AMENDMENT OF THE ISSUED ENVIRONMENTAL AUTHORIZATION FOR THE PROPOSED INSTALLATION OF 2 X 83 000 (83m<sup>3</sup>) LITRE UNDERGROUND TANKS FOR THE STORAGE AND HANDLING OF A DANGEROUS GOOD (DIESEL) LOCATED ON PORTION 1 OF ERF 6154, PIETERSBURG EXT. 8, POLOKWANE LOCAL MUNICIPALITY AREA, CAPRICORN DISTRICT MUNICIPALITY AREA**

**APPLICATION FOR AUTHORIZATION IN TERMS OF SECTION 24(5) OF THE NATIONAL ENVIRONMENTAL MANAGEMENT ACT, 1998 (ACT NO. 107 OF 1998)**

1. The Limpopo Department of Economic Development, Environment and Tourism (LEDET) granted Environmental Authorisation (EA) for the proposed installation of a 83 000 litre (83m<sup>3</sup>) underground Diesel tank on Portion 1 of Erf 6154, Pietersburg Ext.8, Polokwane Municipality, Capricorn District on 3 March 2022.
2. Application was made to LEDET that the EA be amended from the proposed installation of a 83 000 litre (83m<sup>3</sup>) underground Diesel tank to the proposed installation of 2 x 83 000 litre (83m<sup>3</sup>) underground Diesel tanks on Portion 1 of Erf 6154, Pietersburg Ext.8, Polokwane Municipality, Capricorn District.
3. As an Interested and Affected Party notice is hereby given that LEDET have decided to grant authorisation for the amendment of the EA (see copy of letter attached).
4. Should you wish to appeal any aspect of the decision, you must, inter alia, lodge an appeal, in terms of the procedure as outlined in the National Appeal Regulations, 2014, with the MEC, within 20 days of this letter. A copy of the National Appeal Regulations, 2014 is attached to this letter.
