The unlawful construction of infrastructure for the expansion of a vineyard on Portion 13 of Orange Falls Farm no 16, Augrabies Falls Way has commenced. The soil in which the grapes are planted gets ripped in order to create favourable conditions, no soil gets removed by this action. The 10ha area that is developed is done on previously grazed fields. The activity commenced in different time frames: 5ha were developed in 2010; 2.5ha were developed in 2012 and 2.5ha were developed in 2016. During this development there were no new roads constructed. The warehouse in which the grapes gets processed and packed was built in 2001. The site is approximately 9km north-west of Augrabies. The site co-ordinates are **28°39'30.16"S, 20°20'28.81"E**.

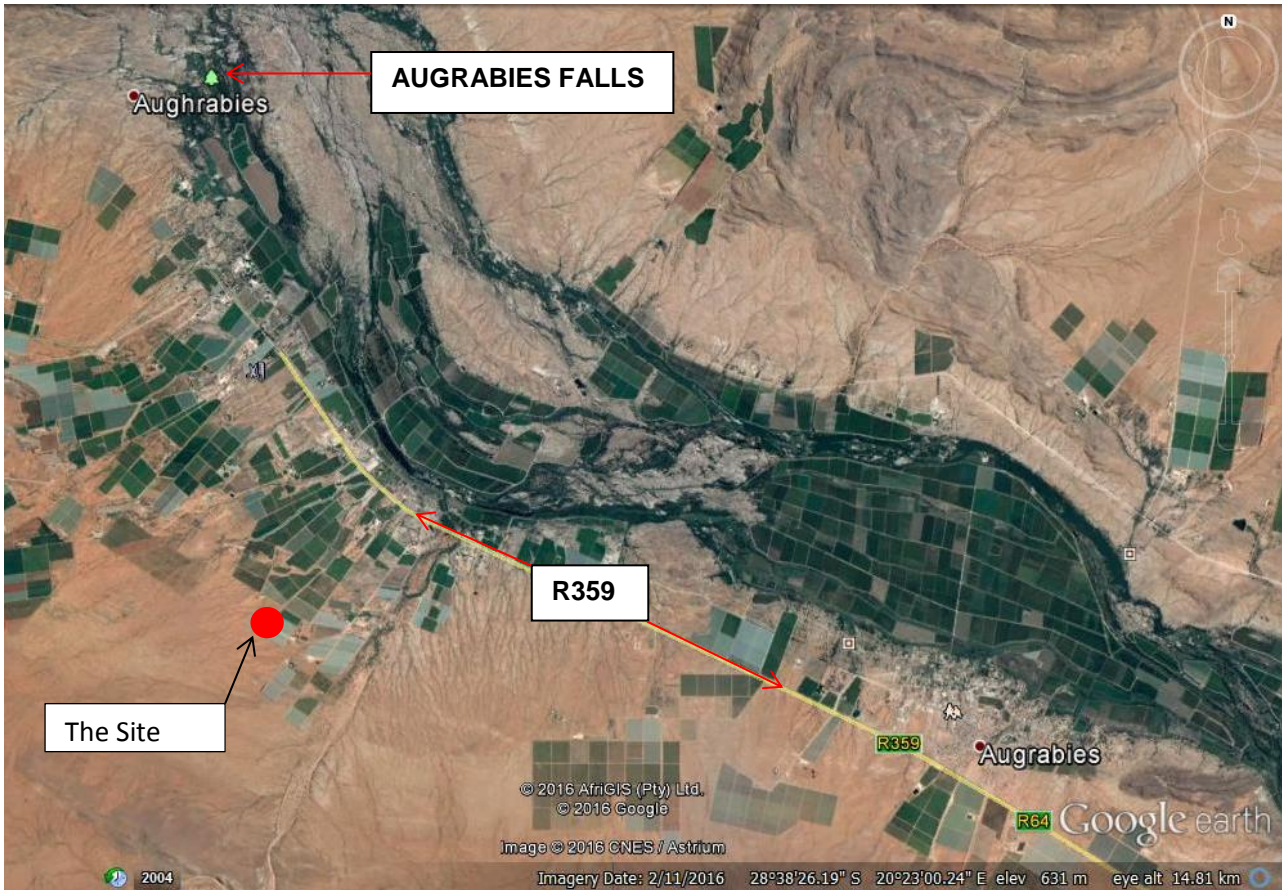


Figure 1: Arial image showing the location of the proposed site and surrounding area.

SITE DESCRIPTION

The site developed into vineyards for table grape production. The site is located on area that is relatively flate and is surrounded by vineyards. The site is agricultural zoned and the surrounding area of the site is already disturbed as a result past grazing activities on site. The warehouse in which the grapes gets processed and packed was built in 2001. Access to the site is gained via existing gravel roads on the farm.

CIVIL AND ELECTRICAL SERVICES

The water supply is from the canal next to the Orange river and currently they have an existing amount of 10ha water rights on their farm they have a 20ha development and therefore they currently rent and extra 10.8ha water rights in order to supply the other 10ha of developed vineyards. They are now on their way to do application for transferring the water rights to their name in order to do away with the renting of the water rights.

The sewerage on the farm gets emptied by a honey sucker by the Kai Garib Local Municipality when full, and the effluent disposed at a municipal safe zone.

The electricity is supplied by Eskom.

ACCESS

The R359 is approximately 2km north-east of the site. Access to the site is gained via existing gravel roads on the farm.

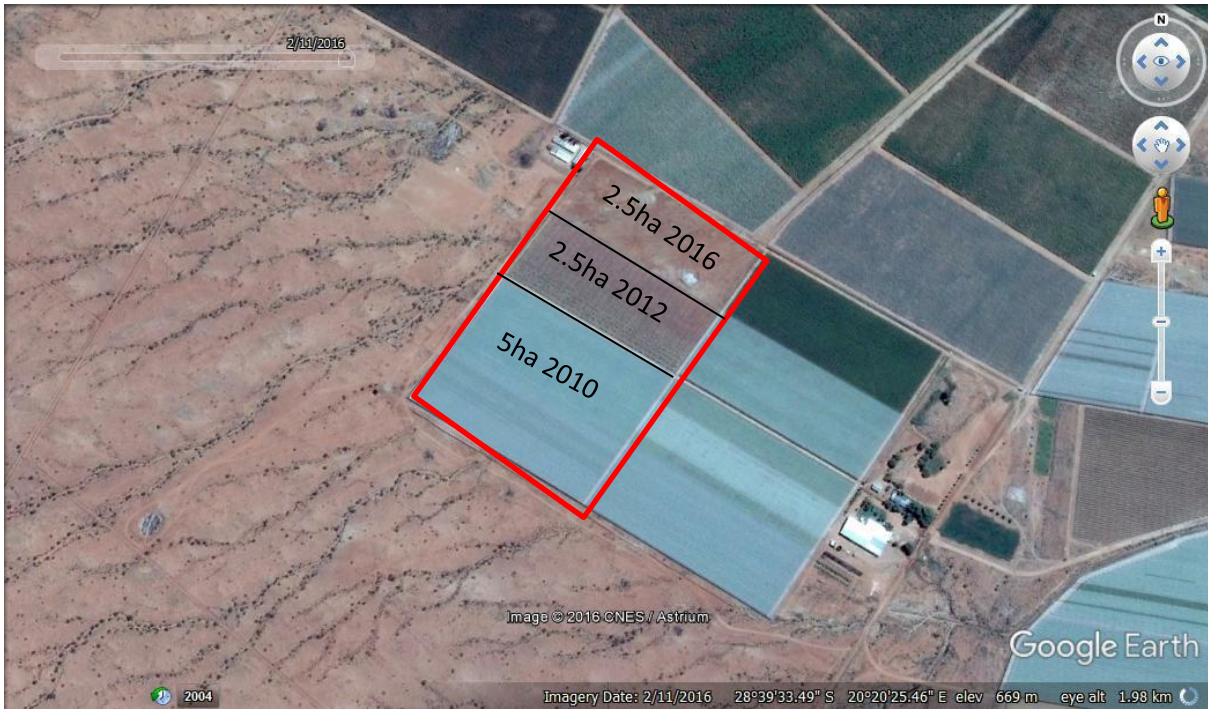


Figure Figure 2: Google Earth aerial photo indicating the affected farm layout and development in each timeframe. The site is indicated by the red rectangle..

CONCLUSION

The best environmental option would be the no-go alternative. However, the social benefits of the proposed project would not be realised.

Although the establishment of vineyards cause some disturbance, with the implementation of the Environmental Management Programme and recommendations from the specialist, the proposed activity is expected to have a low negative impact. However, the benefits of the proposed activity are expected to outweigh any potential negative environmental impacts

It is therefore recommended that this application be authorised with the necessary conditions of approval as described throughout this S24G EIR.
