Your application for the consequences of unlawful commencement of a listed or specified activity received by this Department on 20 March 2019; the acknowledgement of application dated 26 March 2019, the site inspection conducted on 6 May 2019, Department's letter requesting additional information dated 3 July 2019 and the Additional information received by this Department on 2 August 2022 refers.

The application in terms of Section 24G of the National Environmental Management Amendment Act, 2004 (Act No. 8 of 2004) ("NEMA, as amended") read with section 24(2)(a) and 24F(1)(a) of the NEMA is for the following listed activities indicated in Listing Notice 3 of the EIA Regulations, 2014 as amended:

development only triggered listed activity 12(e)(iii) of Listing Notice which has been concluded and no development or operational components listed activity is triggered. Therefore, your application has been referred to the Department's Enforcement Unit to continue with administrative action, with effect from the date of issue of this letter.
