

NOTICE FOR ENVIRONMENTAL AUTHORISATION

Notice is hereby given that an application for Environmental Authorisation in terms of the EIA Regulations, 2010 (Regulations in terms of Chapter 5 of the National Environmental Management Act, 1998, as amended) has been lodged with the KwaZulu-Natal Department of Agriculture and Environmental Affairs.

Project Details : (DM/0038/2013)

eThekweni Water and Sanitation propose to construct six (6) Communal Ablution Blocks (CAB's) in the Dakota Beach Informal Settlement, Isipingo Beach.

This proposed development is part of eThekweni Municipality's 'Provision of water and sanitation to informal settlements within the municipality' which aims to provide more residents with access to formal water and sanitation facilities. In addition, the development will include new pipelines which will link the various CAB toilet platforms to existing main pipelines.

The proposed activity has triggered activity 11,16 and 18 of Listing Notice 1, GNR 544:

11. The construction of:

(xi) infrastructure or structures covering 50 square metres or more, where such construction occurs within a watercourse, OR WITHIN 32m

of a watercourse, measured from the edge of a watercourse, excluding where such construction will occur behind the development setback line.

16. Construction or earth moving activities in the sea, an estuary, or within the littoral active zone or a distance of 100 metres inland of the high water mark of the sea or an estuary whichever is the greater in respect of-

(V) infrastructure covering 50 square metres or more

18. The infilling or deposition of any material of more than 5 cubic metres into, or the dredging, excavation, removal or moving of soil, sand, shell, shell grit, pebbles or rock of more than 5 cubic metres from

(i) a watercourse.

(iv) the littoral active zone, an estuary or a distance of 100 metres inland of the high-water mark of the sea or an estuary, whichever distance is the greater.

The proposed activity requires an application subject to a Basic Assessment and all Interested and Affected Parties (I&APs) are invited to register with the contact person below within 14 days of issuing of this notice. Please phone, fax or e-mail the contact person below. Please note that in order to continue to receive information regarding this project, you must register as an I&AP. A meeting may be held if requested. The time and venue of the meeting will be confirmed with registered I&APs.

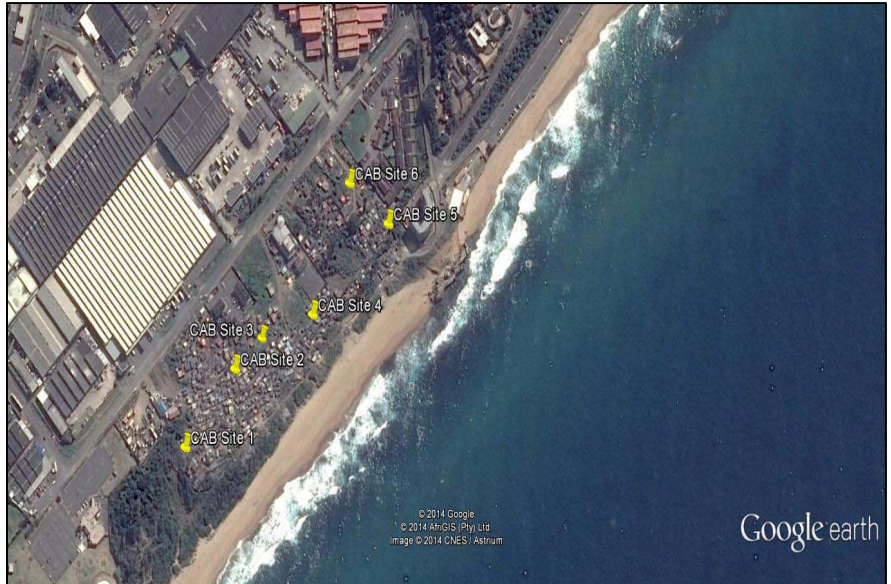


Figure 1: Location of the proposed CAB sites (yellow) in the Dakota Beach Informal Settlement, Google Earth 2014.
