PURPOSE:	The purpose of this notice is to inform interested and affected parties of sampling activities planned to take place in De Beers Consolidated Mines (Pty) Ltd.'s marine prospecting rights area MPT 93/2011 in Sea Concession 6C. Notification is intended for the Department of Mineral Resources, Department of Environmental Affairs and other interested and affected parties.




Figure 1: Map showing the location of the Sampling Target Area

De Beers Marine (Pty) Ltd, the Appointed Operator by De Beers Consolidated Mines (Pty) Ltd.'s for their South African Sea Concession prospecting rights, intends conducting sampling operations (using the mv *Coral Sea*), in the South African Sea Concession 6c between 15-25 March 2017. The position of the target area is provided in the attached map (Figure 1) and coordinates in the table below. Activities will be limited to inshore of the 150m isobath and offshore of the 100m isobath.
