#### A1. BACKGROUND

- A1.1. Situated at the north-eastern edge of the Cedarberg Wilderness Area, in the Agter-Pakhuis area, the Bushmanskloof Rock Painting Landscape represents the remarkably well-preserved record of the Late Stone Age in southern Africa. The paintings are associated to the traditions of San hunter-gatherer and Khoekhoe herders dating back to 10 000years ago.
- A1.2. Falling within the Bushmanskloof Wilderness Reserve, the rock painting sites are situated in the near-pristine environment that would have been very similar to that in which the creators of art would have inhabited.
- A1.3. The excellent state of conservation, the concentration, clarity and detail of the paintings, the environment in which they are situated as well as the long term and ongoing monitoring and management of the sites provides an unprecedent opportunity for archaeological research into the San and Khoekhoe way of life as well as preventative rock art conservation research.
- A1.4. The area has already been the subject of extensive academic work dating back to the late 1950s, and includes the work of Dr Timothy Maggs' rock art survey of the

south-western Cape in the 1960s and the University of Cape Town's Spatial Archaeology Research Unit's work led by Prof. John Parkington in the 1980s and 1990s. Please see below selected references asper the Grading Submission.

- A1.4. The Tollman family purchased the farm in 2004 and established the exclusive, luxury wilderness destination, the Bushmanskloof Wilderness Reserve and Wellness Retreat, with focus around the rock paintings. The Tollman family have invested tremendously to the continued preservation and monitoring of the rock paintings as well as the social and economic upliftment of staff working for the reserve, showcasing heritage conservation directly and tangibly benefit communities.
- A1.5. The sites were nominated on by the Tollman family on 11<sup>th</sup> October 2017 to further preserve and protect the rock paintings. It is the family's intention to nominate these sites to UNESCO for inscription as a World Heritage Site.
- A1.6. Council graded the site as a Grade 1 site on 29 October 2018.

### A2. STATEMENT OF SIGNFICANCE

- A2.1. Bushmanskloof encompasses a Rock Painting Archaeological Landscape that bears graphic testimony to the complete social, political, spiritual and economic history of Stone Age hunter gatherers and Khoekhoe-speaking pastoralists, who inhabited the region for at least the past 10 000 years.
- A2.2. The first instances in the world of direct dating of rock art by Accelerator Mass Spectrometry was achieved from one of the rock painting sites on the reserve during the 1980s, and the exceptional state of preservation of material used at the painted sites provides rare opportunities for direct dating of the art. The rock paintings coupled with the existence of undisturbed, related archaeological deposits within numerous painted shelters, makes Bushmanskloof a landscape with exceptional archaeological research potential.
- A2.3. Numerous sites are characterized by painted imagery that exhibits outstanding clarity of colours and remarkably high levels of detail, along with a great volume of painted figures and a profusion of physically large figures and other, enigmatic imagery, making Bushmanskloof a Rock Painting Landscape of outstanding aesthetic significance.
- A2.4. The sites are located within a near-pristine natural environment with effective access control, and where scientific research is actively encourages. Site visits are facilitated by trained guides, and benefit from regular conservation monitoring, as part of a conservation management plan that been implemented for more than a decade. Allowing for unique research into the efficacy of preventative heritage conservation measures.
- A2.5. Bushmanskloof therefore represents a unique combination of extraordinary aesthetic value and scientific research value, in a single, undisturbed landscape.

### A3. EXECUTIVE SUMMARY

- A3.1 Bushmanskloof Rock Painting Landscape is situated in the north-eastern corner of the Cedarberg within the Bushmanskloof Wilderness Reserve. The remarkably well-preserved sites in the near-pristine environment, as well as the long-term implementation of a rock art management and regular monitoring offer an exceptional archaeological and preventative rock art management research potential.
- A3.2. The site was nominated by the owners of the property, the Tollman Family. The Tollman family through the Bushmanskloof Wilderness Reserve and Wellness Retreat (Pty)Ltd, manage the site and have implemented a Rock Art Management plan together with regular monitoring.
- A3.3. SAHRA did not received any objections to the proposed declaration. Cape Nature however raised a concern that precedence was given to an individual property and that the rock art was not seen within the wider context of the regional Cedarberg Mountain Complex.
- A3.4. The site has been assessed and graded as a Grade 1 site by Council on 29<sup>th</sup> October 2018.

- 3.2. Acknowledgments of receipt of the notifications were received from the Cedarberg Local Municipality, Western Cape Government and Prof John Parkington.
- 3.3. Formal responses were received from Heritage Western Cape in support of the declaration and Cape Nature. Cape Nature support the declaration but have raised that the archaeological heritage of the Cedarberg Mountain Complex (including Bushmanskloof) is of significance that it should be seen within the wider context and declaration of such should take precedence over individual properties
- 3.4. Letters of support were attached to the nomination from United National World Tourism Organisation and Prof Parkington.

7.1. The site is currently and will remain an exclusive luxury wilderness tourist destination operated under the Red Carnation Hotel Collection as the Bushmanskloof Wilderness Reserve and Wellness Retreat (Pty) Ltd.
