Your above mentioned request dated 26 August 2016 refers

With the powers vested to the member of the Executive Council of Health in the Mpumalanga Cemeteries, Crematoria, and Exhumation of the Bodies Act. 2005' Section 14 (1) from the property of Northern BooySENDal Platinum Mine cemetery site to be reburied on the same farm away from the mine activities a permit is granted for the Exhumation and reburial of ±25 graves on condition off:

The reason for the exhumation is the establishment of a new mine. The permission is therefore granted on condition that:

1. Registered undertaker must handle the exhumation;
2. The proceedings must be taking place in such a manner that no offence is given, nor is there any danger to public health;
3. Under no circumstances may the coffin be opened;
4. The necessary authorities must be notified at least seven (7) days before the exhumation take place;

5. The remains must be sealed in an airtight container and placed in a sturdy non-transparent coffin;
6. Any regulations promulgated by the cemetery-authorities must be complied with and;
7. **(Ms E Mahlalela Tel. 0721232298 / 0823731839)** the Manager: Municipal Health services must be notified at least seven (7) days before the exhumation take place.
