Background

The applicant, Eskom Holdings Limited applied for the following activities:

GN R. 387

Item 1(I): The construction of facilities or infrastructure, including associated structures or infrastructure, for —The transmission and distribution of above ground electricity with a capacity of 120 kilovolts or more.

GN R. 386:

- Item 1 (m): The construction of facilities or infrastructure, including associated structures or infrastructure, for any purpose in the one in ten year flood line of a river or stream, or within 32 m from the back of a river or stream where the flood line is unknown, excluding purposes associated with existing residential use, but including (i) canals; (ii) channels; (iii) bridges; (iv) dams; and (v) weirs.
- Item 7: The above ground storage of a dangerous good, including petrol, diesel, liquid petroleum gas or paraffin, in containers with a combined capacity of more than 30 cubic metres but less than 1000 cubic metres at any one location or site.
- for the proposed construction of the Rockdale B Substation with associated secondary infrastructure and two 400kv loop-in power lines into the Arnot-Vulcan power line, within the Steve Tshwete Local Municipality, Mpumalanga Province, as described in the Environmental Impact Report dated May 2010.

The applicant appointed NEMAI Consulting to undertake an environmental assessment process in accordance with the EIA Regulations, 2006.



2. Information considered in making the decision

In reaching its decision, the Department took, inter alia, the following into consideration -

- a) The information contained in the EIR dated May 2010;
- b) The comments received from the Directorate: Biodiversity and Conservation, organs of state and interested and affected parties as included in the EIR dated May 2010;
- c) Mitigation measures as proposed in the EIR dated May 2010 and the EMP;
- d) The information contained in the specialist studies contained within the EIR dated May 2010.
- e) Additional information dated November 2010;
- f) The objectives and requirements of relevant legislation, policies and guidelines, including section 2 of the National Environmental Management Act, 1998 (Act No. 107 of 1998).

3. Key factors considered in making the decision

All information presented to the Department was taken into account in the Department's consideration of the application. A summary of the issues which, in the Department's view, were of

- a) Details provided of the qualifications of the EAP indicate that the EAP is competent to carry out the environmental impact assessment procedures.
- b) The findings of all the specialist studies conducted and their recommended mitigation
- c) The need and desirability for the proposed Rockdale B Substation and the 400kv loop-in power line into Arnot-Vulcan power line.
- d) The EIR dated May 2010 included a description of the environment that may be affected by the activity and the manner in which the physical, biological, social, economic and cultural aspects of the environment may be affected by the proposed activity.
- e) The EIR dated May 2010 identified all legislation and guidelines that have been considered in the preparation of the EIR dated May 2010.
- f) The methodology used in assessing the potential impacts identified in the EIR dated May 2010 and the specialist studies have been adequately indicated.

g) A sufficient public participation process was undertaken and the applicant has satisfied the minimum requirements as prescribed in the EIA Regulations, 2006 for public involvement.

Findings 4.

After consideration of the information and factors listed above, the Department made the

- The floral assessment found that Site Alternative 2 was preferred mainly because a large area of the study area had been transformed by agriculture, mining and infrastructure development. No Red Data Listed floral species were observed during the field survey. Three Orange listed plant species could potentially be located at Site 1 and Site 3. Sites 1& 3 are also affected by
- The faunal assessment found that Site Alternative 2 would have the least ecological impacts.
- The avifaunal assessment found that Site Alternative 2 would have the least avifaunal
- The heritage impact assessment found that all three alternatives would have similar impacts on heritage resources, with no preferred alternative.
- The visual impact assessment found Alternative Site 2 as the most preferred alternative. Its location parallel to existing lines and along agricultural land as well as informal settlements is considered to cause the least impact on the landscape character due to the reduced sensitivity of the landscape along the roads and servitudes.
- The Soil, Land Use and Land Capability Assessment found that Alternative Site 2 to be the
- The geotechnical assessment found that Alternative Site 2 would be the most technically suitable for the construction of a platform for the substation, with no risk of a shallow water table and saturated surface conditions.
- The economic assessment found that all three site alternatives will have similar impacts, hence no site was preferred.
- Public concerns, for example, on issues such as: eco tourism; game farming; division of land/farms; loss property value; pivot centred irrigation systems; visual impact; cumulative impact of power lines; rehabilitation from previous power lines; loss of fauna, flora and wetlands and electric magnetic fields (EMF).

- The identification and assessment of impacts are detailed in the EIR dated May 2010 and sufficient assessment of the key identified issues and impacts have been completed.
- The procedure followed for impact assessment is adequate for the decision-making process.
- The proposed mitigation of impacts identified and assessed adequately curtails the identified impacts.
- All legal and procedural requirements have been met.
- The information contained in the EIR dated May 2010 is accurate and credible.
- EMP measures for the pre-construction, construction and rehabilitation phases of the development were proposed and included in the EIR and will be implemented to manage the identified environmental impacts during the construction process.

In view of the above, the Department is satisfied that, subject to compliance with the conditions contained in the environmental authorisation, the proposed activity will not conflict with the general objectives of integrated environmental management laid down in Chapter 5 of the National Environmental Management Act, 1998 and that any potentially detrimental environmental impacts resulting from the proposed activity can be mitigated to acceptable levels. The application is accordingly granted.

- The Social Impact Assessment found that Impacts on health and social well-being; quality of the living environment; economic material well-being; culture; family and community; institutional, legal, political and equity impacts; and gender relations would be least significant at corridor Alternative 1.
- The Economic assessment using a macro econometric model to determine the impacts of the
 project on the provincial economies of Mpurnalanga and Limpopo and capturing the sectoral
 inter-relationships between the various components of the provincial economies concluded
 that Alternative 1 would be preferred.
- Public concerns, for example, on issues such as: eco tourism; game farming; division of land/farms; loss property value; pivot centred irrigation systems; visual impact; cumulative impact of power lines; rehabilitation from previous power lines; loss of fauna, flora and wetlands and electric magnetic fields (EMF).
- The identification and assessment of impacts are detailed in the EIR dated October 2010 and sufficient assessment of the key identified issues and impacts have been completed.
- The procedure followed for impact assessment is adequate for the decision-making process.
- The proposed mitigation of impacts identified and assessed adequately curtails the identified impacts.
- All legal and procedural requirements have been met.
- The information contained in the EIR dated October 2010 is accurate and credible.
- EMP measures for the pre-construction, construction and rehabilitation phases of the development were proposed and included in the EIR and will be implemented to manage the identified environmental impacts during the construction process.

In view of the above, the Department is satisfied that, subject to compliance with the conditions contained in the environmental authorisation, the proposed activity will not conflict with the general objectives of integrated environmental management laid down in Chapter 5 of the National Environmental Management Act, 1998 and that any potentially detrimental environmental impacts resulting from the proposed activity can be mitigated to acceptable levels. The application is accordingly granted.

- e) The EIR dated October 2010 identified all legislation and guidelines that have been considered in the preparation of the EIR dated October 2010.
- f) The methodology used in assessing the potential impacts Identified in the EIR dated October 2010 and the specialist studies have been adequately indicated.
- g) A sufficient public participation process was undertaken and the applicant has satisfied the minimum requirements as prescribed in the EIA Regulations, 2006 for public involvement.

4. Findings

After consideration of the information and factors listed above, the Department made the following findings -

- Floral assessment found that the western route alternative 1 was chosen as the preferred
 alternative mainly because the power line would affect the least ecologically sensitive habitat.
 No Red Data Listed floral species were observed during the field survey, however, the
 occurrence of Red Data Listed floral species is not discounted.
- The faunal assessment found that Alternative 1 (western corridor) is regarded as the route alternative that would pose the least threat to the overall conservation of the vegetation type, habitat type features and therefore, faunal community structures within the region.
- The Avifaunal assessment found that the western route alternative 1 was the preferred option due to the fact that it incorporated the least amount of ecologically sensitive habitat. It also required the least amount of mitigation measure implementation. This is largely due to it crossing only limited important migratory routes, thereby reducing the overall impacts emanating from collisions.
- The Heritage impact assessment found Alternative 1 would have the least impact on known sites. It is also the route in which the least unknown sites are expected to occur.
- Visual impact assessment found corridor Alternative 1 as the most preferred alternative. Its
 location parallel to existing lines and along agricultural land as well as informal settlements is
 considered to cause the least impact on the landscape character due to the reduced
 sensitivity of the landscape along the roads and servitudes.
- The Soil, Land Use and Land Capability Assessment found that the two routes traverse areas with a wide range of land uses with very limited irrigated agriculture land uses. Impacts are expected to be low upon the condition that pylons are placed outside of areas with irrigation infrastructural developments. There was no preferred alternative as both will have similar impacts, if mitigated.

- for the proposed construction of a 400kv power line between the Rockdale B Substation and the proposed Wolwekraal Substation within the Greater Marble Hall Local Municipality, Elias Motsoaledi Local Municipality and Steve Tshwete Local Municipality in the Mpumalanga and Limpopo Provinces, as described in the Environmental Impact Report dated October 2010.

The applicant appointed NEMAI Consulting to undertake an environmental assessment process in accordance with the EIA Regulations, 2006.

Information considered in making the decision 2.

In reaching its decision, the Department took, inter alia, the following into consideration -

- a) The information contained in the EIR dated October 2010;
- b) The comments received from the Directorate: Biodiversity and Conservation, organs of state and interested and affected parties as included in the EIR dated October 2010;
- c) Mitigation measures as proposed in the EIR dated October 2010 and the EMP;
- d) The information contained in the specialist studies contained within the EIR dated October 2010.
- e) The objectives and requirements of relevant legislation, policies and guidelines, including section 2 of the National Environmental Management Act, 1998 (Act No. 107 of 1998).

Key factors considered in making the decision 3.

All information presented to the Department was taken into account in the Department's consideration of the application. A summary of the issues which, in the Department's view, were of the most significance is set out below.

- a) Details provided of the qualifications of the EAP indicate that the EAP is competent to carry out the environmental impact assessment procedures.
- b) The findings of all the specialist studies conducted and their recommended mitigation measures.
- c) The need and desirability for the proposed 400kv power line between the proposed Rockdale B Substation and the proposed Wolwekraal Substation.
- d) The EIR dated October 2010 included a description of the environment that may be affected by the activity and the manner in which the physical, biological, social, economic and cultural aspects of the environment may be affected by the proposed activity. Mady

Annexure 1: Reasons for Decision

1. Background

The applicant, Eskom Holdings Limited applied for the following activities:

GN R. 386

Item 1(I): The construction of facilities or infrastructure, including associated structures or infrastructure, for –The transmission and distribution of above ground electricity with a capacity of 120 kilovolts or more.

GN R. 386:

- Item 1 (m): The construction of facilities or infrastructure, including associated structures or infrastructure, for any purpose in the one in ten year flood line of a river or stream, or within 32 m from the back of a river or stream where the flood line is unknown, excluding purposes associated with existing residential use, but including (i) canals; (ii) channels; (iii) bridges; (iv) dams; and (v) weirs.
- Item 7: The above ground storage of a dangerous good, including petrol, diesel, liquid petroleum gas or paraffin, in containers with a combined capacity of more than 30 cubic metres but less than 1000 cubic metres at any one location or site.

- 37. Protected trees must not be cut or removed prior to a licence being obtained in line with the National Forests Act, 1998 (Act No. 84 of 1998) administered by the Department of Agriculture, Forestry, and Fisheries.
- 38. The EMP must include the final route map indicating all sensitive features or aspects which were avoided and those that could not be avoided. (Game farms, centre pivots, wetlands, rivers, ridges, heritage resources, visual intrusion, vegetation including protected trees, communities etc.)
- 39. Liaison with communities and land owners is to be done prior to construction in order to provide sufficient time for them to plan livelihood activities.
- 40. An integrated waste management approach must be implemented that is based on waste minimisation and must incorporate reduction, recycling, re-use and disposal where appropriate. Any solid waste shall be disposed of at a landfill licensed in terms of section 20 (b) of the National Environment Management Waste Act, 2008 (Act No. 59 of 2008).

General

- 41. A copy of this authorisation must be kept at the property where the activity/ies will be undertaken. The authorisation must be produced to any authorised official of the Department who requests to see it and must be made available for inspection by any employee or agent of the holder of the authorisation who works or undertakes work at the property.
- Where any of the applicant's contact details change, including the name of the responsible person, the physical or postal address and/or telephonic details, the applicant must notify the Department as soon as the new details become known to the applicant.
- 43. The holder of the authorisation must notify the Department, in writing and within 48 (forty eight) hours, if any condition of this authorisation cannot be or is not adhered to. Any notification in terms of this condition must be accompanied by reasons for the non-compliance. Non-compliance with a condition of this authorisation may result in criminal prosecution or other actions provided for in the National Environmental Management Act, 1998 and the regulations.

27. The applicant must compile an operational EMP for the operational phase of the activity or alternatively, if the applicant has an existing operational environmental management system, it must be amended to include the operation of the authorised activity.

Site closure and decommissioning

Should the activity ever cease or become redundant, the applicant shall undertake the required actions as prescribed by legislation at the time and comply with all relevant legal requirements administered by any relevant and competent authority at that time.

Specific conditions

- 29. Anti-collision devices such as bird flappers must be installed where the power lines crosses avifaunal corridors. The input of an avifaunal specialist must be obtained for the fitting of the anti-collision devices onto specific sections of the line once the exact positions of the towers have been surveyed and pegged.
- 30. A floral and faunal specialist should be present during the planning and pegging of the final route alignment to ensure that the positions of pylons result in minimum impacts on sensitive vegetation, protected trees and habitats.
- 31. An agricultural specialist must form part of the walk through in the final route determination in order to identify critical centre pivot irrigation systems which need to be avoided by the power line.
- The wetlands, including, rivers, riparian zones and river banks must be designated as sensitive areas and must be demarcated as such. No construction activities (including placing of pylons, temporary ablution, fuel storage, storing of equipment, waste disposal, construction camps, vegetation clearing, excavations, access roads, soil stockpiling and material storage) must take place in such sensitive area.
- 33. A wetland specialist should be present during the pegging of the final route alignment to ensure that no pylons are placed within wetlands and river banks.
- 34. No activities will be allowed to encroach into a water resource without a water use authorisation being in place from the Department of Water Affairs.
- 35. No exotic plants may be used for rehabilitation purposes. Only indigenous plants of the area may be utilised.

19. Records relating to monitoring and auditing must be kept on site and made available for inspection to any relevant and competent authority in respect of this development.

Recording and reporting to the Department

- 20. All documentation e.g. audit/monitoring/compliance reports and notifications, required to be submitted to the Department in terms of this authorisation, must be submitted to the *Director:* Compliance Monitoring at the Department.
- 21. The holder of the authorisation must submit an environmental audit report upon completion of the construction and rehabilitation activities.
- The environmental audit report must indicate the date of the audit, the name of the auditor and the outcome of the audit in terms of compliance with the environmental authorisation conditions as well as the requirements of the EMP.

Commencement of the activity

- 23. The authorised activity/ies shall not commence within twenty (20) days of the date of signature of the authorisation.
- An appeal under section 43 of the National Environmental Management Act (NEMA), Act 107 of 1998 (as amended), does not suspend an environmental authorisation or exemption, or any provisions or conditions attached thereto, or any directive, unless the Minister, MEC or delegated organ of state directs otherwise.

Notification to authorities

25. Fourteen (14) days written notice must be given to the Department that the activity will commence. Commencement for the purposes of this condition includes site preparation. The notice must include a date on which it is anticipated that the activity will commence. This notification period may coincide with the period contemplated in 23 above.

Operation of the activity

26. Fourteen (14) days written notice must be given to the Department that the activity operational phase will commence.

Notification of authorisation

- The holder of the authorisation must notify every registered interested and affected party, in 11. writing and within 12 (twelve) calendar days of the date of this environmental authorisation, of the decision to authorise the activity.
- 12. The notification referred to must
 - specify the date on which the authorisation was issued; 12.1
 - inform the interested and affected party of the appeal procedure provided for in 12.2 Chapter 7 of the Environmental Impact Assessment (EIA) Regulations, 2010;
 - advise the interested and affected party that a copy of the authorisation will be 12.3 furnished on request; and
 - 12.4 give the reasons for the decision.

Management of the activity

The Environmental Management Plan (EMP) submitted as part of Application for EA must be 13. amended and submitted to the Department for written approval prior to commencement of the activity. The recommendations and mitigation measures recorded in the EIR dated September 2010 must be incorporated as part of the EMP. Once approved, the EMP must be implemented and adhered to.

Monitoring

- The applicant must appoint a suitably experienced independent Environmental Control Officer 14. (ECO) for the construction phase of the development that will have the responsibility to ensure that the mitigation/rehabilitation measures and recommendations referred to in this authorisation are implemented and to ensure compliance with the provisions of the EMP.
- 15. The ECO shall be appointed before commencement of any authorised activity/ies.
- Once appointed, the name and contact details of the ECO must be submitted to the Director: 16. Compliance Monitoring of the Department.
- The ECO shall keep record of all activities on site, problems identified, transgressions noted 17. and a task schedule of tasks undertaken by the ECO.
- The ECO shall remain employed until all rehabilitation measures, as required for 18. implementation due to construction damage, are completed and the site is ready for operation

Conditions

Scope of authorisation

- The preferred route corridor Alternative 1 (western corridor) and the final amendment corridor as shown on page 40 of the EIR are approved.
- Authorisation of the activity is subject to the conditions contained in this authorisation, which
 form part of the environmental authorisation and are binding on the holder of the authorisation.
- 3. The holder of the authorisation shall be responsible for ensuring compliance with the conditions contained in this environmental authorisation. This includes any person acting on the holder's behalf, including but not limited to, an agent, servant, contractor, sub-contractor, employee, consultant or person rendering a service to the holder of the authorisation.
- The activities authorised may only be carried out at the property as described above.
- Any changes to, or deviations from, the project description set out in this authorisation must be approved, in writing, by the Department before such changes or deviations may be effected. - for the proposed construction of a 400kv power line between the Rockdale B Substation and the proposed Wolwekraal Substation within the Greater Marble Hall Local Municipality, Elias Motsoaledi Local Municipality and Steve Tshwete Local Municipality in the Mpumalanga and Limpopo Provinces, as described in the Environmental Impact Report dated October 2010.

The applicant appointed NEMAI Consulting to undertake an environmental assessment process in accordance with the EIA Regulations, 2006.

Information considered in making the decision 2.

In reaching its decision, the Department took, inter alia, the following into consideration -

- a) The information contained in the EIR dated October 2010;
- b) The comments received from the Directorate: Biodiversity and Conservation, organs of state and interested and affected parties as included in the EIR dated October 2010;
- c) Mitigation measures as proposed in the EIR dated October 2010 and the EMP;
- d) The information contained in the specialist studies contained within the EIR dated October 2010.
- e) The objectives and requirements of relevant legislation, policies and guidelines, including section 2 of the National Environmental Management Act, 1998 (Act No. 107 of 1998).

Key factors considered in making the decision 3.

All information presented to the Department was taken into account in the Department's consideration of the application. A summary of the issues which, in the Department's view, were of the most significance is set out below.

- a) Details provided of the qualifications of the EAP indicate that the EAP is competent to carry out the environmental impact assessment procedures.
- b) The findings of all the specialist studies conducted and their recommended mitigation measures.
- c) The need and desirability for the proposed 400kv power line between the proposed Rockdale B Substation and the proposed Wolwekraal Substation.
- d) The EIR dated October 2010 included a description of the environment that may be affected by the activity and the manner in which the physical, biological, social, economic and cultural aspects of the environment may be affected by the proposed activity. Mady

- e) The EIR dated October 2010 identified all legislation and guidelines that have been considered in the preparation of the EIR dated October 2010.
- f) The methodology used in assessing the potential impacts Identified in the EIR dated October 2010 and the specialist studies have been adequately indicated.
- g) A sufficient public participation process was undertaken and the applicant has satisfied the minimum requirements as prescribed in the EIA Regulations, 2006 for public involvement.

4. Findings

After consideration of the information and factors listed above, the Department made the following findings -

- Floral assessment found that the western route alternative 1 was chosen as the preferred alternative mainly because the power line would affect the least ecologically sensitive habitat.
 No Red Data Listed floral species were observed during the field survey, however, the occurrence of Red Data Listed floral species is not discounted.
- The faunal assessment found that Alternative 1 (western corridor) is regarded as the route alternative that would pose the least threat to the overall conservation of the vegetation type, habitat type features and therefore, faunal community structures within the region.
- The Avifaunal assessment found that the western route alternative 1 was the preferred option
 due to the fact that it incorporated the least amount of ecologically sensitive habitat. It also
 required the least amount of mitigation measure implementation. This is largely due to it
 crossing only limited important migratory routes, thereby reducing the overall impacts
 emanating from collisions.
- The Heritage impact assessment found Alternative 1 would have the least impact on known sites. It is also the route in which the least unknown sites are expected to occur.
- Visual impact assessment found corridor Alternative 1 as the most preferred alternative. Its
 location parallel to existing lines and along agricultural land as well as informal settlements is
 considered to cause the least impact on the landscape character due to the reduced
 sensitivity of the landscape along the roads and servitudes.
- The Soil, Land Use and Land Capability Assessment found that the two routes traverse areas
 with a wide range of land uses with very limited irrigated agriculture land uses. Impacts are
 expected to be low upon the condition that pylons are placed outside of areas with irrigation
 infrastructural developments. There was no preferred alternative as both will have similar
 impacts, if mitigated.

- The Social Impact Assessment found that Impacts on health and social well-being; quality of the living environment; economic material well-being; culture; family and community; institutional, legal, political and equity impacts; and gender relations would be least significant at corridor Alternative 1.
- The Economic assessment using a macro econometric model to determine the impacts of the
 project on the provincial economies of Mpurnalanga and Limpopo and capturing the sectoral
 inter-relationships between the various components of the provincial economies concluded
 that Alternative 1 would be preferred.
- Public concerns, for example, on issues such as: eco tourism; game farming; division of land/farms; loss property value; pivot centred irrigation systems; visual impact; cumulative impact of power lines; rehabilitation from previous power lines; loss of fauna, flora and wetlands and electric magnetic fields (EMF).
- The identification and assessment of impacts are detailed in the EIR dated October 2010 and sufficient assessment of the key identified issues and impacts have been completed.
- The procedure followed for impact assessment is adequate for the decision-making process.
- The proposed mitigation of impacts identified and assessed adequately curtails the identified impacts.
- All legal and procedural requirements have been met.
- The information contained in the EIR dated October 2010 is accurate and credible.
- EMP measures for the pre-construction, construction and rehabilitation phases of the development were proposed and included in the EIR and will be implemented to manage the identified environmental impacts during the construction process.

In view of the above, the Department is satisfied that, subject to compliance with the conditions contained in the environmental authorisation, the proposed activity will not conflict with the general objectives of integrated environmental management laid down in Chapter 5 of the National Environmental Management Act, 1998 and that any potentially detrimental environmental impacts resulting from the proposed activity can be mitigated to acceptable levels. The application is accordingly granted.
