# NOTICE OF A BASIC ASSESSMENT PROCESS AND WATER USE AUTHORISATION PROCESS FOR THE THE CONSTRUCTION OF THE BALAMHLANGA RIVER BRIDGE 3505 AT KM 41.4 ON DISTRICT ROAD D1834 (KM 41.810 - KM 42.000) WITHIN THE UMHLABUYALINGANA LOCAL MUNICIPALITY – EMPANGENI REGION

Notice is hereby given with intent to commence a Basic Assessment process as stipulated in the Environmental Impact Assessment Regulations (2014), as amended, under Government Gazette 38282 of 04 December 2014; Notice No. GNR 982, 983 and 985 read in conjunction with Listing Notice No. GNR 324, 326 and 327 of 07 April 2017 of Listing Notice, Activity 12, 19 and 31 for the proposed project.

This notice is also given in terms of the National Water Act, 1998 (Act No. 36 of 1998), for the undertaking of a Water Use Authorisation Application process under Section 21 water uses:

- Taking water from a water resource.
- Impeding or diverting the flow of water in a watercourse.
- Altering the beds, banks, course or characteristics of a watercourse.

#### PROJECT DESCRIPTION

Afzelia Environmental Consultants (Pty) Ltd has been appointed by Mott MacDonald (Pty) Ltd on behalf of the KwaZulu Natal Department of Transport to conduct an Environmental Impact Assessment (EIA) in the form of a Basic Assessment (BA) and Water Use Authorisation (WUA) Application process for the proposed upgrade of the Balamhlanga River Bridge 3505.

The proposed development is located near the intersection of the D1834 and L2106 (Also known as A1188) roadways. The GPS coordinates of the site are **27°22'1.47"S**; **32°14'46.71"E**.

It is proposed that the D1834 to be realigned such that the new bridge crossing can be positioned optimally. It has been recommended by the Engineer that the existing bridge be closed due to Health and Safety concerns. The proposed new bridge is approximately 20m downstream of the existing crossing. It is proposed to be 61.5m long and 13.1m wide bridge to improve road safety. The portion of the D1834 road is from KM40+800 to KM42+000. The proposed realignment is approximately1.2km in length with a width of approximately 9.5 and walkways are only at the approach and departure of bridge.

The purpose of this notice is to (i) inform the public and Interested and Affected Parties (I&AP's) about the proposed project, (ii) share information about the proposed project which will be of relevance to the potentially affected parties, and (iii) give I&AP's an opportunity to register and comment. Should you wish to be kept informed during the Basic Assessment and Water Use License processes, it is important that you register as an I&AP. 


Figure 1 – Locality Map
