IKUTSHELANI LENCWAJANA?

Lencwajana iqonde ukukuchazela ngolwazi njengomunye wabantu abanentshisakalo noma abathintekayo (Interested and Affected Parties) maqondana nokuhlongozwa uMnyango wezoku-Thatha KwaZulu-Natali, uhlongoza ukwakha ibhuloho emigwaqweni uL2013.

Lencwajana iphinde ikwazise kabanzi ngohlelo olenziwayo, uhlelo locwaningo ngesimo semvelo lapho kuzothuthukiswa khona umgwaqo (uL2013) kanye no kwakhiwa kwebhuloho. Lencwajana ibuye ikwazise ukuthi ungazibandakanya kanjani kuloluhlelo ukuze ukwazi ukothola imininingwane mayelana naloluhlelo, bese uveza imibono yakho kanye nokungaculiseki kwakho. Ukuchathezelana ngolwazi kuyisisekelo sokuzibandakanya nomphakathi futhi kukunikeza ithuba lokudlala indima ebalulekile ekuqaleni kohlelo. Ukuzibandakanya komphakathi kusiza kakhulu ekucaciselweni ngolwazi nasekuxazululweni kwezinkinga ezingadalwa yintuthuko ehlongozwayo..

IPHATHELENE NANI LENTUTHUKO?

uMnyango wezoku-Thutha KwaZulu-Natali uhlongoza ukuthuthukisa ingqalazinda yomgwaqo ngokwakhiwa kwebhuloho emigwaqeni uL2013 endaweni yase Hoffental. Kuzothuthukiswa ngokwakhiwa ibhuloho kulomugwaqo ukuze izakhamuzi zendawo zikwazi ukuhamba nasezindaweni ezingaphesheya komufula.

Kuhlongozwe ukulungiswa kanye nokwakha lokhu:

- Ibholoho lomgwaqo uL2013, lihlongozwa ukuba libe nobude Kanye nobubanzi: 15m x 2m

Ngaphansi komthetho wokuphatha nocwaningo lweziMvelo ka 2014 (EIA Regulations 2014), uMnyango wezoku-Thutha KwaZulu-Natal, kumele wenze ucwaningo lezimvelo (phecelezi Basic Assessment) ngale ntuthuko ehlongozwayo, ngenxa yokuthi ukwakhiwa kwebhuloho kuse mfuleni.

IZIPHI IZINTO EZINGADALA UMONAKALO KWIMVELO EZIHAMBISANA NALE NTUTHUKO?

Uma sekwenziwa ucwaningo, osocwepheshe kanye nabacwaningi bezemvele bazovakashela indawo lapho amabhuloho lizokwakhiwa khona. Ukuvakasha kwabo kuyoba ukuyokwenza ucwaningo bebhaka uhlobo lemvelo kanye nokubona ukuthi ukuphi okungase babhekane nakho umasebenza ucwaningo olubanzi. Osocwepheshe abazobe besiza ngocwaningo kuyoba:

- Usocwepheshe bezeNdalo (Ecological Assessment)
- kanye nosocwepheshe bezo mhlaba omanzi (Wetland Assessment)
- Usocwepheshe ohlolwa okomthelela wamagugu (Heritage Impact Assessment)

Ekuphawuleni komphakathi ku lelithuba lokubandakanya umphakathi kuyasiza ekubeni sikwazi ukuthola izinkinga nesingqinamba ezizodinga uphando umakwenziwa ucwaningo lezemvelo. Ucwaningo luzokhombisa izindawo ekumele zinakekelwe zingaphazanyiswa, Luphinde lubheke indlela engeke yenze umonakalo omkhulu kwimvelo.

Ucwaningo lezemvelo luzozama ukuthola nokuphendula lokhu okulandelayo:

- Lizozama ukuveza imizwa yomphakathi luphinde luveze ukuthi imvelo izokonakala kangakanani ngenxa kokwakhiwa lama bhuloho;
- Ukubheka kabanzi umhlaba oncono lapho kungakhiwa khona lama bhuloho;
- Luzokhomba izindlela zokuvikela umonakalo kwimvelo;
- Luphinde lwenze uhlelo lokubandakanya umphakathi, ngoku thatha imibono nemibuzo engaba khona mayelana nalentuthuko.

INGANI KUDINGEKA UCWANINGO LWEZEMVELO?

Ngaphansi komthetho wohlelo lokuvikelwa kwezemvelo owagunyazwa kumthetho ka Hulumeni owaziwa ngokuthi unombolo R982 wonyaka ka 2014, ngokwenxenywe ka 24 (5) okungumthetho kaZwelonke wokuphathwa kwezemvelo ngokomthetho kanombolo 107 ka 1998. uMnyango weZokuthutha KwaZulu Natali, udinga imvumo kuMnyango waKwaZulu-Natal ophathelene neZomnotho neNtuthuko, nezokuVakasha kanye nokongiwa kweZemvelo yokwenza lentuthuko abayihlongozayo. Njengoba lentuthuko ibalwa njengentuthuko ethinta imvelo kunesidingo sokwenziwa ucwaningo lezemvelo.

uMnyango wezoku-Thutha esifundazweni sa-KwaZulu-Natali, uqashe abakwa At Gedezar Consulting, njengabacwaningi abazimele (EAP). Baqokelwe ukwenza uphenyo ngocwaningo oludingakalayo ngohlelo oluhlohlongozwayo. Ucwaningo luzokhombisa izindawo ekumele zinakekelwe zingaphazanyiswa, luphinde lubheke indlela engeke yenze umonakalo omkhulu kwimvelo.

INQUBO YOKUSEBENZISANA NOMPHEKATHI

Kubalulekile ukuthi umphakathi uzibandakanye njengengxenywe yenqubo yokusebenzisana nomphakathi ekuqaleni kwawo wonke umsebenzi. Ukuze siqiniseke ukuthi ukusebenzisana nomphakathi kuyaphumelela, kufanele kwenziwe okulandelayo:

- **ISINYATHELO SOKUQALA:** Kufanele kubekhona izaziso zenqubo yokucwaningwa kwezemvelo emaphelandabeni omphakathi, ezifundazwe kanye nawezwe lonke.
- **ISINYATHELO SESIBILI:** Kubhaliswe abathintekayo nabo bonke abantu ababandakanywa yilenqubo lapho kugcinwa khona imininigwane
- **ISINYATHELO SESITHATHU:** Kubekhona ukuxhumana, ukubonisana nokunikana imibiko nabathintekayo, kusetshenziswa izindlela ezifana nemihlangano yomphakathi lapho kusaqhutshwa izifundo zokucwaningwa kwemvelo.
- **ISINYATHELO SESINE:** Kumenywe abathintekayo ukuze nabo bafake imibono yabo embhalweni wombiko wezocwaningo. Abantu bazonikezwa izinsuku ezingu 30 ukuba baphawule.

- **ISINYATHELO SESIHLANU:** Kubhalwe imibono nezimpawulo zomphakathi kuhlelo lokuloba kwezimpawulo bese konke lokho kuba yingxenye yombiko wocwaningo wezemvelo.
