### **DU PLESSIS DAM SOLAR PV1 GRID CONNECTION: SWITCHING STATION AND 132KV POWERLINE CONNECTING THE DU PLESSIS DAM SOLAR PV1 TO THE MULILO CLUSTER 1 SUBSTATION, DE AAR, NORTHERN CAPE PROVINCE: NOTIFICATION OF ENVIRONMENTAL AUTHORISATION ISSUED 28 SEPTEMBER 2022**

Notice is given in terms of the National Environmental Management Act (Act No 107 of 1998) and the 2014 EIA Regulations, as amended, that the Environmental Authorisation (EA) was issued to Du Plessis Dam Solar PV1 (Pty) Ltd for the above-mentioned project. It was issued on 28 September 2022 by the Acting Chief Director: Integrated Environmental Authorisations of the Department of Forestry, Fisheries and the Environment (DFFE). A copy of the EA (inclusive of the reasons for the decision in Annexure 1, Page 14 of the EA) is attached hereto.
