Notice is given in terms of the National Environmental Management Act (Act No 107 of 1998) and the 2014 EIA Regulations, as amended, that the Environmental Authorisation (EA) was issued to the Wag 'n Bietjie (Pty) Ltd for the above-mentioned project. It was issued on 22 November 2022 by the Acting Chief Director: Integrated Environmental Authorisations of the Department of Forestry, Fisheries and the Environment (DFFE). Should any person wish to lodge an appeal against this decision, he/she must submit the appeal to the Appeals Administrator, and a copy of the appeal to the applicant, any registered interested and affected party, and any organ of state with interest in the matter within 20 days from the date that the notification of the decision was sent to the registered interested and affected parties by the applicant.
