AMENDMENT OF AN ISSUED ENVIRONMENTAL AUTHORISATION FOR THE PROPOSED ESTABLISHMENT OF TWO DAMS AND ASSOCIATED IRRIGATION INFRASTRUCTURE ON THE REMAINING EXTENT OF THE FARM FAIRVIEW 605-LT AT AGATHA, GREATER TZANEEN MUNICIPALITY (LDEDET REF: 12/1/9/2-M31)

This with reference to the Environmental Authorisation (EA) that was issued to Faeroes Properties (Pty) Ltd by the Limpopo Department of Economic Development, Environment and Tourism (LDEDET) on 24 January 2017 for the proposed establishment of two dams on the Remaining Extent of the Farm Fairview 605-LT at Agatha, within the Greater Tzaneen Municipality.

1. Amendment of the Environmental Authorisation

The original EA indicated the base width of the two dams as 6m and 10m respectively. This has been corrected to 83m and 103m respectively, as was indicated in the Environmental Impact Report which was submitted to LDEDET as part of the Environmental Impact Assessment.

We would hereby like to **notify** all registered Interested and/or Affected Parties (I&APs) and stakeholders, including yourself, of LDEDET's decision to amend the EA. A copy of the EA amendment is available from Polygon upon request.

2. Appeals

Should you feel that LDEDET wrongly decided to amend the EA and you wish to appeal the decision, you can do so in terms of the National Appeal Regulations, published in Government Notice R.993 on 08 December 2014 in terms of NEMA. Should you wish to appeal, the appeal must be lodged with the MEC for Economic Development, Environment and Tourism (Limpopo) before or on 22 October 2017, on an official form which can be obtained from LDEDET. At the same time, copies of the appeal must be sent to the applicant.

The appeal must be accompanied by the following:

- i) A statement setting out the grounds of the appeal;
- ii) Any supporting documentation which is referred to in the appeal submission and
- iii) A statement, including supporting documentation, by the appellant to confirm compliance with Regulation 4(1) of the Appeal Regulations (meaning that the appeal was submitted to LDEDET, the applicant and any other I&AP or organ of state with interest in the matter within 20 days from the issuing of the notice regarding the EA).
