undertaken by Graham Projects does not constitute an activity that is listed terms of EIA Regulation R.544 Listing notice 1, 2 and 3 of 18 June 2010 promulgated under National Environmental Management Act, 1998 (Act No. 107 of 1998). As such, written environmental authorization in terms of the National Environmental Management Act, 1998 (Act No. 107 of 1998) is not required from this Department prior to the undertaking of the said activity.

- 3. This determination is based on the following:
 - 3.1. The proposed project entails construction of a shopping centre on a 3.1 hectare tribal area that has been cleared and utilized as a soccer field and no green fields will be used.
 - 3.2. The proposed infrastructure entails installation of 30 000 litres of elevated tanks as a freshwater supply for the proposed project.
 - 3.3. Septic tanks designed to treat 13 kl/day are proposed as well as soakaway system of 70m in length to accommodate 8 kl/day as a sewage treatment system for the proposed project.
- 4. Should there be changes, relocation or deviations from the area where this project is going to be undertaken without any approval from this Department, you are reminded that such action may constitute an offence in terms of NEMA 24F (1)(a)
- 5. Furthermore in accordance with section 28 of NEMA, Graham Projects is obliged to exercise a duty of care and remediation of any environmental damage that may occur during the lifetime of the project.
