**BASIC ASSESSMENT NOTICE: APPLICATION FOR ENVIRONMENTAL  
AUTHORISATION THE EXPANSION AND RELATED OPERATION OF 4 ADDITIONAL  
BROILER POULTRY HOUSES ON PORTION 36 (A PORTION OF PORTION 19) OF THE  
FARM TWEERIVIER 197-JQ, IN MADIBENG LOCAL MUNICIPALITY, NORTH-WEST  
PROVINCE**

In accordance with the requirements of Section 41 (2) (b) of the Environmental Impact Assessment Regulations as amended, we wish to notify “any organ of state having jurisdiction in respect of any aspect of the activity”. In accordance with the requirement, please find here-with a letter notifying you of the Basic Assessment being carried out by Westleigh Environmental Services. Westleigh has been appointed as independent registered environmental assessment practitioners by Heavy Feather 2 (Pty) Ltd to facilitate their application for environmental authorisation for the related development and operation of a broiler poultry production farm.

Our applicant proposes to construct 4 additional broiler chicken houses with a total carrying capacity of 136 000 (one hundred and thirty six thousand) poultry units. Each house will have a carrying capacity 34 000 (thirty-four thousand) poultry units per production cycle, upon placement of day old broiler chickens. This activity triggers a need to apply for environmental authorisation for the following listed activities;

- Listing Notice 1, Activity 40 (i) (ii) as listed in GN. R 327 of 07 April 2017 for “*The expansion and related operation of facilities for the concentration of poultry, excluding chicks younger than 20 days, where the capacity of the facility will be increased by;*”
  - (i) *more than 1 000 poultry where the facility is situated within an urban area;*  
*or*
  - (ii) *more than 5 000 poultry per facility situated outside an urban area”*
