NOTIFICATION OF DECISION ON APPLICATION: GRANTING OF THE ENVIRONMENTAL AUTHORISATION FOR THE PROPOSED PROSPECTING RIGHT COMBINED WITH A WASTE LICENCE APPLICATION TO PROSPECT FOR DIAMONDS ALLUVIAL (DA), DIAMONDS GENERAL (D) AND DIAMONDS IN KIMBERLITE (DK) ON THE REMAINING EXTENT, PORTION 1, PORTION 2 AND PORTION 3 (BOORWATER) OF THE FARM BULTFONTEIN 327, REGISTRATION DIVISION: HAY, NORTHERN CAPE PROVINCE. - 3. Morgenson Mining (Pty) Ltd is the holder and responsible person for the EA.
- 4. Your attention as a key stakeholder for the above-mentioned project, is drawn in terms of regulation 4(2) of the NEMA: EIA Regulations, 2014 that the applicant must ensure that—
 - all registered interested and affected parties are provided with access to the decision and the reasons for such decision; and
 - the attention of all registered interested and affected parties is drawn to the fact that an appeal may be lodged against the decision in terms of the National Appeal Regulations if such appeal is available in the circumstances of the decision.
 - For the purpose of this regulation, the decision includes the complete environmental authorisation granted or refused.
- 5. Should you as a stakeholder wish to appeal; an appeal must, inter alia, be lodged as prescribed in regulation 4 of the National Appeal Regulations, 2014, with a Member of the Executive Council, Ministry of Department of Environmental Affairs within 20 days.
- 6.
