

Notice is hereby given that an application for Environmental Authorization (EA) in terms of the EIA Regulations, 2014 as amended will be lodged with the KZN Department of Economic Development, Tourism and Environmental Affairs (EDTEA). A Water Use Authorisation application in terms of section 40 of the National Water Act, No.36 of 1998 (NWA) will also be lodged with the Department of Water and Sanitation (DWS).

Baleni Road Upgrade (29°36'55.42"S 30°13'39.96"E)

Project Details: Makhaotse, Narasimulu and Associates (Pty) Ltd, on behalf of the Msunduzi Municipality, have appointed EnviroPro to provide Environmental Authorisation and Management services for the proposed Baleni Road (L1459) upgrade. The site falls within Wards 3 & 40 of the Msunduzi Local Municipality, Umgungundlovu District Municipality. The proposed project area is located in KwaNxamalala and is approximately 26km from the Pietermaritzburg CBD at the following location: 29°36'55.42" S 30°13'39.96" E (see figure 1 below). Environmental Authorisation through a Basic Assessment Process is required for i) infilling more than 10m³ into a watercourse (Listing Notice 1, Activity 19), and ii) infrastructure or structures with a physical footprint of 10m² or more within sensitive areas as identified in an environmental management framework (Listing Notice 3, Activity 14). A Water Use Authorisation is also required in terms of Section 21 (c) & (i) of the NWA for any activity that will alter the beds, banks, and flow of a watercourse. Ukugunyazwa Kwemvelo Ngenqubo Yokuhlola Eyisisekelo kuyadingeka ukuze i) kugwaliswe indawo/umgodi ongaphezu kuka-10m³ endaweni egeleza amanzi (Isaziso Sohlu 1, Umsebenzi 19), kanye ii) nokwakhiwa kwengqalasizinda noma izakhiwo ubukhulu bazo obuwu-10m² noma ngaphezulu ezindaweni ezinezinto zemvelo ezibucayi njengoba zikhonjwe kwi-Environmental Management Framework (Isaziso sohlu 3, Umsebenzi 14). Imvume Yokusebenza endaweni Enamanzi nayo iyadingeka ngokweSigaba 21 (c) & (i) se-NWA nganoma yimuphi umsebenzi ozoshintsha imibhede, amabhangwe, nokugeleza komfula. Bonke Abanentshisekelo Nabathintekayo abafuna ulwazi olwengeziwe bayamenywa ukuba babhalise kumuntu obhalwe ngezansi zingakapheli izinsuku ezingu-60 zaleli bhodi lezaziso.
