In terms of section 27 or a mining right in terms of section 22 of the said Act. You/your concern is hereby invited to a public meeting on Monday 6 August 2012 at 17h00 at the Magaliesburg Hotel. The closing date for receiving your registration, comments, concerns and objections is 10 August 2012. The locality of the mining area is depicted on the Regulation 2(2) attached hereto). The sole land owner directly affected by the proposed mining venture is Goldkoppie (Pty) Ltd.

The opencast mining method (bench mining) will be applied. Blasting by means of explosives will be conducted, but will be outsourced to an outside consultant, which means that there will not be any explosives magazine on site. As the pit is not expected to be deeper than 20 metres vertically below surface, the water table is very unlikely to be intersected.

It is important to note that no beneficiation will take place on the mining area, but will take place elsewhere. This will minimise the environmental impacts dramatically.
