Dear Mr. Miza and Mr. Molaudzi,

Following our email communication with Ms. Sephai (see below), kindly confirm whether the List of Types of Objects (the List) had been added to your Prohibited and Restricted List (P & R) of goods that may not be exported from the country without a SAHRA approved permit.

Our understanding from meeting dated 5 December 2012 was that the List was going to be placed on the P & R goods list as a matter of urgency. If it was not done, we would like this to be finalized by Thursday 28 February 2013.

We are open to discussion regarding placement of the List or any other concerns you may have at your earliest convenience.

I am Lynn Abrahams, newly appointed heritage officer at SAHRA and I have been assigned to deal with this matter initiated by Azola Mkosana. Hence my email to follow up on progress made since your meeting with SAHRA officials dated 5 December 2012 regarding role of Customs in safeguarding heritage objects.

Following the recommendations from your meeting, a list of Types Of Heritage Objects was subsequently mailed to you (12/12/12) by Azola Mkosana to enable your office to facilitate publishing these in your list of prohibited goods. It would be appreciated if you could kindly inform us on the progress made in this regard?

As agreed, kindly make available a list of officials to be trained at the OR Tambo International Airport, Durban Port of Entry, Cape Town International/Cape Town Port of Entry and Lebombo as well as providing us with a schedule of your training. This would aid SAHRA in determining how we may plan around training Customs officials regarding their role as heritage inspectors as stipulated in the National Heritage Resources Act, No. 25 of 1999 (S50).

We look forward to your reply.

Following our meeting with Mr. Matome, Mr. Mulaudzi and Mr. Miza, attached is a List that describes the Types of Heritage Objects that are protected in terms of the National Heritage Resources Act, No. 25 of 1999 which may not exported without a permit from SAHRA. SAHRA was requested to forward the List which should be included as part of the Prohibited and Restricted goods that are illegal to export without a permit from SAHRA. We understand that the List is perhaps too detailed, therefore, we would be very willing to review what is published if there is limited space.
