### **ERF 174009 BREE STREET CNR STRAND STREET: VOC MILITARY STORE: SPELUM RESOLUTION**

The City of Cape Town Environmental and Heritage Resources Management Branch would like to refer SAHRA to the Spatial Planning, Environment & Land Use Management Committee resolution dated 13 April 2011 (*SPEL18/04/11 - APPLICATION FOR CONSENT: ERF 174009, CNR STRAND AND BREE STREETS, CAPE TOWN*) in which the proposed development on the VOC military store at the Lutheran Church Complex was refused, and in which it was further resolved "That the South African Heritage Resources Agency (SAHRA) be requested to address the grading of the building, the complex in question, and the City Block, in light of its potential national significance, as a matter of urgency. "

The City is thus accordingly referring the above request to SAHRA for urgent consideration of the potential National Heritage Site and Grade 1 status of the entire block bounded by Strand, Buitengracht-, Waterkant- and Bree Streets.

Copies of all of the comments and the heritage studies are a matter of public record and can be made available to SAHRA at your earliest request.
