Notice is hereby given that applications in terms of the EIA Regulations 2010, Section 24 of the National Environmental Management Act, 1998 (Act 107 of 1998) (NEMA), Section 45 of the National Environmental Management: Waste Act, 2008 (Act 59 of 2008) (NEMWA) and Section 40 of the National Water Act, 1998 (Act 36 of 1998) (NWA) has been lodged with Mpumalanga Department of Economic Development, Environment and Tourism (MDEDET), Department of Environmental Affairs (DEA) and Department of Water Affairs (DWA) respectively. The activities to be undertaken requires applications subject to an Environmental Impact Assessment (EIA) process as required by Section 4 of GN R718 and Sections 26 to 35 of GN R 543 of the EIA regulations.

Applicant: Mashala Hendrina Coal (Pty) Ltd

Project Name: De Wittekrans Coal Mine

Project Location: The proposed project is situated on the western side of the N11 between the towns of Ermelo (40 km north-northwest) and Hendrina (15 km south-southeast) within the Msukaligwa and Steve Tshwete Local Municipalities, which fall under the Gert Sibande District Municipality of the Mpumalanga Province. It is situated within the Olifants Water Management Area in the B12A quaternary drainage region with the Klein-Olifants River transecting the site.

Proposed Activity: Mashala Hendrina Coal holds a current prospecting right and has applied for a mining right in respect of coal reserves on the farm De Wittekrans 218 IS, Groblershoek 191 IS, Groblershoop 192 IS, Israel 207 IS and Tweefontein 203 IS. The proposed mining methods to be used are opencast mining, making use of the roll-over method and the bord and pillar mining method for the underground sections. Included in the infrastructure to be constructed is a service water treatment plant, sewage treatment plant, coal beneficiation plant, co-disposal facility, mine water storage dams and waste storage areas.
