# INTRODUCTION

Our company was appointed by Ferret Mining and Environmental Services (Pty) Ltd to relocate a grave that is affected by the proposed Intibane Colliery of Wescoal (Pty) Ltd.

We are hereby informing you that we are in the process of applying for permission to relocate the remains of this grave that is buried on the abovementioned property.

# LOCATION OF THE GRAVE

The grave, affected by mining activities, is located on the following property which forms part of the Victor Khanye Local Municipality:

• Portion 16 of the farm Vlakvarkfontein 213 IR, Victor Khanye Local Municipality, Mpumalanga Province. GPS coordinates: S26° 03' 47.0" E28° 53' 19.5". Refer Addendum A.

# **PROJECT INFORMATION**

The grave in question is adversely affected by the proposed Intibane Colliery of Wescoal (Pty) Ltd. We have conducted an extensive social consultation process (as required by Act 25 of 1999) in order to identify the unknown buried individual and to obtain permission for exhumation and re-interment from affected families, communities and other bona fide interested and affected parties. This process comprised the following:

# • Site notices

Bilingual site notices were placed at the grave on Thursday, 23 May 2013. Refer Addendum B for copies of the site notice and Addendum C for photographs depicting the notice at the grave site.

No response was received to the site notice.

# • Newspaper notices

Newspaper notices were placed in a national newspaper (Daily Sun) on Wednesday, 31 July 2013) and a regional newspaper (Streek News) on Friday, 2 August 2013. Refer Addendum D for copies of the published notices.

Only one response was received to the notice that was placed in the Daily Sun. Ms. Thandi Letsoalo contacted the project manager to indicate that her family has graves on the farm Vlakvarkfontein 213 IR. However, after the position and description of the grave that is to be relocated was discussed with Ms. Letsoalo she indicated that this was not her family's graves which are located on another portion of the farm.

# • Interviews with local residents

Discussions with local residents represent the third component of the social consultation process. The project manager assisted by a translator Mr. Shorty McGina spent some time in the vicinity of the mine on Friday, 19 July 2013 in an attempt to establish whether any families for the deceased could be identified. These consultations included discussions with Ms. Emily Skosana (born Mahlangu) and Mr. Phillip Ditsego who both have homesteads adjacent to the mine.

Mr. Ditsego indicated that when he first arrived on the farm in 1968, the grave was already there. Ms. Skosana concurred and indicated that when she and her family arrived on the farm in 1988 the grave was already in existence. Neither one of the two families knew the identity of the deceased, nor where the family of the deceased may be found. They also confirmed that since the time when they first settled on the farm they have never seen anyone visiting the grave site.

The information received during the interviews with local residents indicate that the grave is likely older than 45 years.


