You are required to comply with the Gauteng Provincial Environmental Management Framework Standard 2018 and Environmental Management Specifications.

A copy of this registration letter and the Gauteng Provincial Environmental Management Framework Standard 2018 must be kept on site and where the holder has a publicly accessible website, be placed on such website, and must be made available on request.

Registration lapses if commencement does not occur within 10 years of receipt of the registration number.

N.B. Please note that the definition of "Zone 1" says that the geographical area in "Zone 1" is depicted as the Urban Development Zone in terms of the Gauteng Provincial Environmental Management Framework in which infill, densification and concentration of urban developments are facilitated.

Therefore, compliance with the Standard does not negate the need for the proponent to comply with all other applicable legislation.

The holder of the Registration letter is required to notify, in writing, the adjacent landowners of this decision within 14 days of receipt of this letter and the provisions to appeal as stated below:

An appeal may be lodged by any member of the public against the issuing of the registration in terms of section 43 of the National Environmental Management Act, 1998 and the National Appeal Regulations, 2014, which sets out the appeal procedures. The appeal should be lodged within 20 days, from the date of receipt of the Registration letter to the Appeals Administrator by any of the following means:

In the event of change of ownership of the registered development, the new owner must submit the relevant declaration and details contemplated in Appendix 5 of the GPEMF Standard 2018 (Declaration of change of ownership) within 30 days of finalisation of the change.
