AMENDMENT OF THE ENVIRONMENTAL AUTHORISATION ISSUED ON 27 JUNE 2018 FOR THE PROPOSED CONSTRUCTION OF THE GRASKOPPIES ON-SITE ESKOM SUBSTATION, LINKING SUBSTATION AND ASSOCIATED 132KV POWER LINE NEAR LOCRIESFONTEIN WITHIN HANTAM AND KHAI-MA LOCAL MUNICIPALITIES, NORTHERN CAPE PROVINCE


