## PURPOSE OF THIS DOCUMENT

Exxaro Coal (Pty) Ltd (Exxaro) is applying for environmental authorisation to undertake several listed activities and water uses at its existing opencast mining operations at the Grootegeluk Coal Mine (Grootegeluk). Grootegeluk is situated within the jurisdiction of the Lephalale Local Municipality, and the Waterberg District Municipality, about 13.5 km north-west of the town of Lephalale on the farms Mc Cabesvley 331, Goedehoop 457, Vooruit 449, Leeuwdrift 312, Daarby 458, Appelvlakte 448, Grootegeluk 459, Enkelbult 462, Nelsonskop 464 and Hieromtrent 460. The proposed project will extend existing opencast mining operations onto the farms Enkelbult 462 LQ and Turfvlakte 463 LQ (Turfvlakte), which form part of the existing mining right area. Applications for environmental authorisation and a water use licence are required before extended mining activities may commence on the Turfvlakte site.

The proposed extension to the existing opencast operations will consist of two pits, namely Pit 1 and Pit 2 on the farm Turfvlakte, which is located within the existing Grootegeluk Coal Mine's Mining Right, LP 46 MRC. Pit 1 will be 158 ha in size and will be 88 m deep, while Pit 2 will be 64 ha and 109 m deep.

The preferred option is to mine Pit 1 and then Pit 2 to produce 1.5 million tonnes per annum run of mine (ROM) coal over a period of 12 years. The alternative option is to first mine Pit 2 and then Pit 1 to produce 3 million tonnes per annum run of mine (ROM) coal over a period of seven years. The interburden and coal mined from Pit 1 and Pit 2 will be transported to and handled at the existing Grootegeluk Coal Mine plants. The mining operations will be undertaken 24 hours per day, six days a week.

The proposed infrastructure to be established at surface in support of the coal mining operation includes haul roads connecting the proposed pits to the existing Grootegeluk Coal Mine operations; a laydown area for the mine equipment and offices; water management infrastructure (sumps and pipelines); a waste management area (waste skips); and a sub-station.

It is anticipated that the coal produced from the proposed Turfvlakte Coal Mine will supplement the coal feed to the Grootegeluk Coal Mine plants and contribute to its current supply to Eskom and other clients in the domestic market.

The Draft Scoping Report was available for public review and comment for a period of 30 days, from **Monday**, **27 January 2020** to **Tuesday**, **25 February 2020**. Subsequent to unrest in the town of Lephalale that prevented the public meetings from proceeding on the scheduled dates, the meetings were postponed, and the public comment period was extended **to Monday**, **9 March 2020**. Kindly find herewith a response to each of the points raised.

• Water use authorisation required:

An application for a Water Use Licence will be submitted to the DWS as part of the Turfvlakte project.

The following NWA sections will be applicable to the application:

- Section 21(c) and Section 21(i):
  - Removal of pans within mining area; and
  - Proximity of mine infrastructure to wetlands/pans within the area.
- Section 21(g):
  - Dust suppression.

- Section 21(j):
  - Dewatering of pit areas to continue mining.

More detail on the WUL application will be presented to the stakeholders during the impact assessment phase of the project.

• Progress on success of rehabilitation of pans at Sandloop to be submitted as well as relocation of baboon spiders:

The licence applicable to this issue was only issued in October 2019. Grootegeluk Coal Mine is currently in the process of finalising the relocation plan for the baboon spiders and the other species of importance. Grootegeluk is also in the process of finalising the final offset study, including a monitoring plan for the offset area that was identified to the north of the mine. This offset area includes areas around a drainage line that forms a seasonal tributary of the Sandloop Spruit. The Proof of Concept Study, for the relocation of the pans, is also being finalised.

The above mentioned studies/plans will be submitted no later than 18 April 2020, as per the Licence conditions.

-

• Environmental audit to be submitted on existing operations highlighting impacts to characteristics of water courses and proposed mitigation:

The proposed Grootegeluk Mine expansion into the wetland areas has not been initiated and it is only planned for quarter 2 of 2020. Current mining activities is still more than 500m from the closest pans. The anticipated impacts as indicated in the original wetland study and associated application are still the same.

Included in the above mentioned licence, issued in October 2019, is the authorisation for the destruction of the pans in front of the pit and included in the 30-year LOM plan and thereafter. The mitigation for this impact is the proposed offset. Supporting this offset is the Offset Management Plan and Proof of Concept Study (both are being finalised). The intent is to kick-off the Proof of Concept Study to confirm if the pans can be successfully relocated

/ recreated in the 2<sup>nd</sup> Quarter of 2020. The outcome of this process will be refined and included in the final rehabilitation plans for Grootegeluk. As mentioned above, all these reports will be submitted to the Department before 18 April 2020.

The first external audit for the above mentioned WUL will be conducted in May 2020 as part of the larger Grootegeluk IWUL audit.

With regard to the proposed Turfvlakte Open Pit project, the scenario will be different since not all pans within the project area will be impacted. The impacts will be assessed and mitigation measures will be formulated during the impact assessment phase of the project. We will keep you informed and your comments welcomed.
