Re: **HUMANSRUS SOLAR 4 PARK – WATER SUPPLY**

Your email dated the 9th of February 2016 and the Alkantpan water supply confirmation letter dated the 19th of January 2016 refers:

We hereby confirm that the Siyathemba Municipality do have the capacity at our Prieska Water Treatment Works to supply the amount of purified water as requested to Alkantpan from where it can be used for the construction and operation of the Humansrus Solar 4 PV Facility.

- A volume of approximately 6000m³ per annum for two years during the construction phase;
- A volume of approximately 3000m³ per annum for a 20 year operational phase predominantly for the cleaning of the solar panels.

We hereby put it on record that the Siyathemba Municipality supply purified water from its Water Treatment Works in Prieska to Alkantpan as per their request and we will not be held responsible for the inability to deliver water to the Humansrus Solar 4 Park via the Alkantpan pipeline.

AVAILABILITY OF WATER FOR PHOTOVOLTAIC POWER GENERATION FACILITY – HUMANSRUS SOLAR 4 (PTY) LTD. – 75MW

This is a letter of pledge that confirms Alkantpan Test Range has the capacity to provide Humansrus Solar 4 with required water volumes during construction phase, 6000 m³/annum, for two years and 3000 m³/per annum during operational phase (20 years).

A memorandum of agreement shall be entered into by both parties when Humansrus Solar 4 (Pty) Ltd. received confirmation as preferred bidder to construct this power generation facility.

This confirmation shall only be valid as long as the Alkantpan Test Range water reticulation system continues to be operational.
