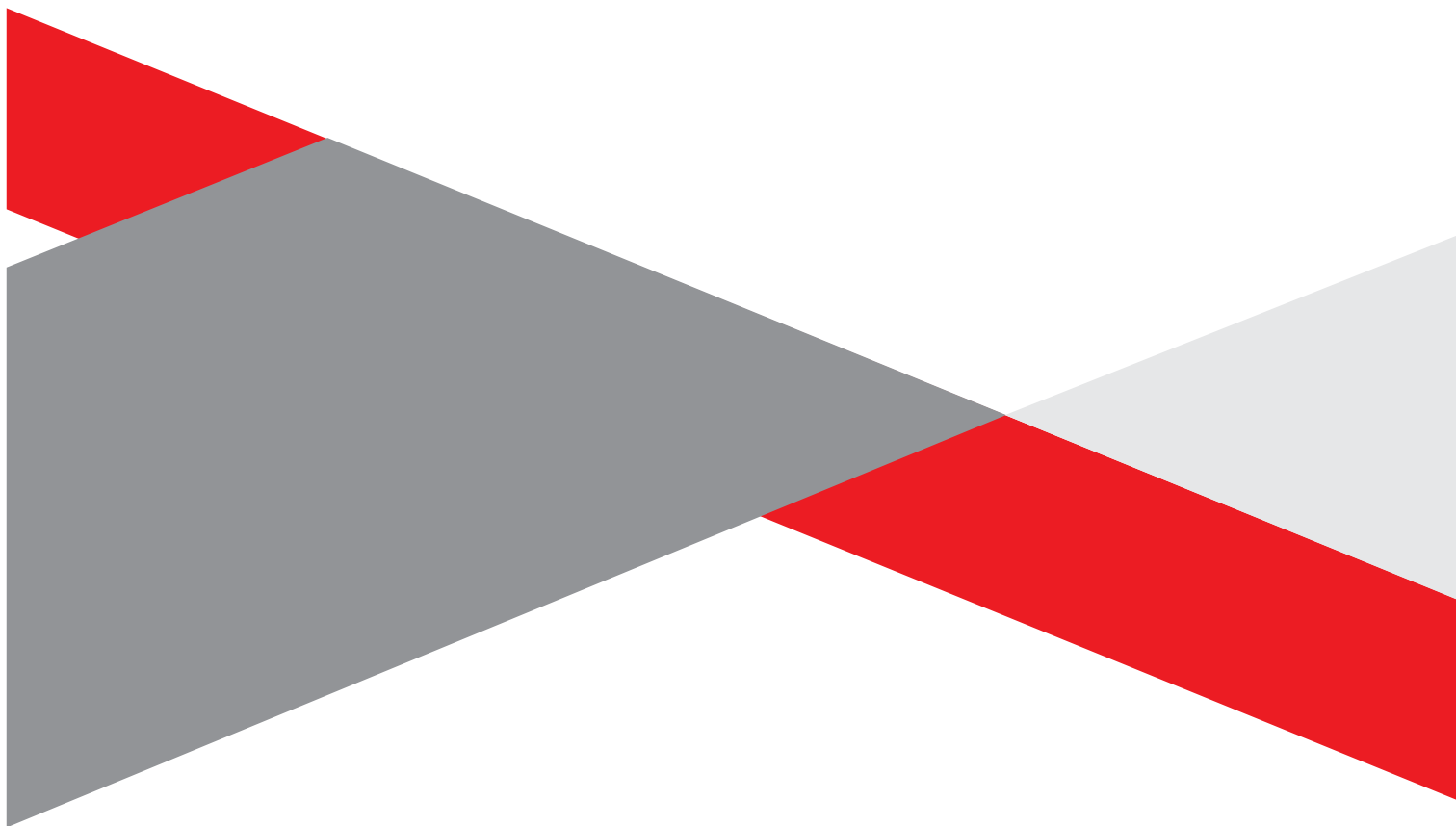

## **ENVIRONMENTAL IMPACT ASSESSMENT PROCESS**

In accordance with the EIA Regulations, 2014 (as amended) published in terms of Section 24(5) of the National Environmental Management Act (No. 107 of 1998) (NEMA), the applicant requires Environmental Authorisation from the Department of Small Business Development, Tourism and Environmental (DESTE), as the Competent Authority. In terms of Section 24(5) of NEMA, the EIA Regulations 2014 (as amended) and Listing Notices (GNR 327, GNR 325, and GNR 324), the application for EA is subject to the completion of a Scoping/EIA process. The application is required to be supported by comprehensive, independent environmental studies undertaken in accordance with the EIA Regulations, 2014 (as amended).

The EIA is an effective planning and decision-making tool. It allows for potential environmental consequences resulting from a proposed activity to be identified and appropriately managed during the construction, operation, and decommissioning phases of development. It also provides an opportunity for the project applicants to be forewarned of potential environmental issues, and allows for the resolution of impacts identified and reported on as part of the EIA process, as well as provides opportunity for dialogue with key stakeholders and Interested and Affected Parties (I&APs).
