Heavitree (Pty) Ltd wish to apply for Environmental Authorisation and a Water Use License Application for the proposed establishment of a 1.7 million m³ dam, and cultivation of approximately 135 ha of land, located on Rem of Express No. 15029, Rem of Heavitree No. 15976, Farm Portion No. 18322, and Farm Portion GS No. 17935, within the Inkosi Langalibalele Local and uThukela District Municipality, Estcourt, KwaZulu-Natal.



The proposed project triggers Listed Activities in GNR 327 and GNR 325, thus a Scoping and EIA Process is required. A Water Use License is also required.
