The proponent is required to notify the Director: Compliance Monitoring in writing, fourteen (14) days prior to the commencement of the development of Heineken Sedibeng brewery solink solar photovoltaic (pv) facility, on Er 244, Portion 0 in Graceview Ext. 3 and Erf 243, Portion 0 in Graceview Ext 1, Midvaal Local Municipality.

In the event of change of ownership of the registered development, the new owner must submit the relevant declaration and details contemplated in Appendix 5 of the GPEMF Standard 2018 (Declaration of change of ownership) within 30 days of finalisation of the change.

The reference number, namely GPEMF/19-20/0054 is now the registration number.
