**RE: ULUNDI SHOOTING RANGE – HERITAGE REPORT FINDINGS**

**Proposal to Protect the Graves and Mitigate the Concerns in the Report.**

We have perused the report and Amafa's recommendations to enable work proceed on the project.

In the light of the above, we have reconfigured the site layout by removing the Rifle Range that is a major obstacle to one of the graves.

In other instances, only 2 grave sites are within the project site boundary.

On one, the grave is just outside Range 6 away from the edge. The other one is on the property boundary line on the Eastern side.

In all the 3 instances, we have marked a buffer of 25m across the center of the grave and built a fence around each one with a lockable gate.

This will be a 2.4m high ClearVu fence erected as mentioned above. Inside the fenced area will be a hedge to protect the area.
