1.  
 The Plaintiff is **THOMASI MTHEMBENI DLAMINI: ID NO. (750116 5852 088)** an adult Male, residing at Kilum Location, near Skofill Secondary School Underberg, KWAZULU-NATAL.  
 (Hereinafter referred to as "the Plaintiff")

2.  
 THE DEFENDANT is **BALANDILE RITA DLAMINI: ID NO. (750819 0714 084)** an adult Female residing at, Kilum Location, near Skofill Secondary School, Ingwe rural Underberg KWAZULU-NATAL.  
 (Hereinafter referred to as "the Defendant")

3.  
 Plaintiff and Defendant were married to each other in community of property, on the 7th day of July 2006 at Underberg and the aforesaid marriage still subsists.

4.  
 Plaintiff and Defendant are domiciled within the area of jurisdiction of the above Honorable Court.

5.  
 a) There are four (4) children born out of the aforesaid marriage namely:  
 i. Thokoza Dalmiini a major male 23 years of age;  
 ii. Lungiswa Dlamini a major female 21 years of age;  
 iii. Siyadumisa Lindani Dlamini a minor male aged 15 years;  
 iv. Swelihle Dlamini a minor male aged 12 years.  
 b) It would be in the best interest of the children if the plaintiff were awarded custody of the children, they are presently in the care of the plaintiff.

6.  
 The marriage relationship between the Plaintiff and the Defendant has reached such a state of disintegration that there is no reasonable prospect of restoration of a normal marriage relationship between them; therefore, the marriage relationship between the parties has irretrievably broken down for the following reasons:  
 6.1 Lack of communication;  
 6.2 Both parties have lost their love and affection for each other;  
 6.3 The parties have not lived together as husband and wife for continuous period of at least 1 year prior to the institution of the divorce proceedings;  
 6.4 The defendant has left the Matrimonial home in 2016;  
 6.7 In the premises the marriage relationship between the parties have irretrievably broken down as contemplated in terms of Section 4 (1) of the Divorce Act of 1979 as amended.

**WHEREFORE THE PLAINTIFF PRAYS FOR AN ORDER AS FOLLOWS:**  
 a) A Divorce Decree;  
 b) Primary care of Children born of the marriage to be awarded to the Plaintiff;  
 c) That both parties shall have full parental responsibilities and in terms of Section 19 and 20 read with Section 1(1) and section 18(2) of the Children's Act 38 of 2005 in respect of minor children.  
 d) The Defendant shall have access and contact to children to be exercised in the best interest, with a minimum degree of disturbance to their routine, education and school activities, as follows:  
 i) On every short and long school holidays to be shared equally;  
 ii) On every fathers' days and birthdays;  
 iii) Reasonable telephonic contacts;  
 iv) Contact as per any other arrangements;  
 v) Major decisions involving the lifestyle of minor children to be made jointly by both parties with the best interest of the children in mind.  
 e) Cost of this Action, if the action is defended;  
 f) Further and / or alternative relief.
