**PROPOSED ILANGA CSP FACILITY AND ASSOCIATED INFRASTRUCTURE ON A
SITE NEAR UPINGTON, NORTHERN CAPE PROVINCE

NOTIFICATION OF AMENDMENT OF ENVIRONMENTAL AUTHORISATION

Ilanga CSP 1 obtained an authorisation for the construction of a CSP facility and associated infrastructure on a site near Upington, Northern Cape Province (DEA Ref No: 12/12/20/2056) in October 2011, with an amendment issued in January 2013 (amending the applicant name to Ilangalethu Solar Power (Pty) Ltd).

In terms of Regulation 38(2)(a) and 38(3)(d) of the EIA Regulations, Ilangalethu Solar Power (Pty) Ltd requested an amendment of the authorisation for a change of holder of the environmental authorisation (to reflect the SPV responsible for the project development) and correction of the property name (as reflected in the title deed).

In terms of Regulation 10(2)(a), the applicant hereby advises registered interested and affected parties on this project that the Department has approved the request for amendment of the authorisation for the project. The amended environmental authorisation (dated 27 June 2014), conditions for authorisations, as well as reasons for the decision are attached to this letter of notification. This amendment must be read in conjunction with the Authorisation dated 26 October 2011.

As an interested and affected party your attention is drawn to Chapter 7 of the EIA Regulations which regulates appeal procedures. Should you wish to appeal any aspect of the decision by DEA, you must lodge a notice of intention with the Minister within twenty (20) days of the date of the decision.
