# NOTIFICATION OF AN ENVIRONMENTAL AUTHORISATION & MINING RIGHT APPLICATION: FOR THE PROPOSED ZANDRIVIERS DRFIT (ZRD) AREAS AND ASSOCIATED INFRASTRUCTURE WITHIN THE MADIBENG MUNICIPALITY, NORTH WEST PROVINCE

### Purpose of the Project:

GIBB (Pty) Ltd (GIBB) has been appointed by PPC Ltd (PPC) to undertake Environmental Authorisation and Mining Right Application in terms of the National Environmental Management Act, 1998 (Act No. 107 of 1998) (NEMA) and Environmental Impact Assessment (EIA) Regulations 2014), as well as Mineral and Petroleum Resources Development Act, 2002 (Act No. 28 of 2002) (MPRDA) and the National Water Act, 1998 (Act No. 36 of 1998) (NWA), for the proposed Assen and Tambotie Areas and associated infrastructure within the Madibeng Municipality, North West Province.

You have been identified as a potential interested and affected party (I&AP) for the above mentioned project. Further information relating to the proposed development is provided in the section below.

#### PROJECT BACKGROUND:

PPC Ltd (PPC) has for many years operated an excavation pit and processing plan in the greater Assen area. A new limestone ore body (ZRD North and South) has been identified for mining. The proposed Mining operation is an open cast limestone mine. It is envisage that the proposed ZRD project will mine 350°000 tonnes/year of limestone and this limestone will be transported to the existing Beesterkraal mine for further processing.

The proposed Zandriviers Drift (ZRD) Mining Right Application will include the following: The ZRD North Ore Body; ZRD North Overburden Dump Area Alternatives 1 & 2; Overburden Dump Road; Haul road; ZRD South Ore body; ZRD South Overburden Dump Area; Overburden Dump Road and Haul Road. 


Figure 1: Proposed ZRD Areas and Associated Infrastructure Locality Map
