

ENVIRONMENTAL AUTHORISATION APPLICATION FOR THE PROPOSED UPGRADE TO SUBLIME ACCESS ROAD AND NEW INTERSECTION WITH R580, EXARRO MATLA MINE, EMALAHLENI LOCAL MUNICIPALITY, MPUMALANGA PROVINCE

GIBB (Pty) Ltd (GIBB) has been appointed by Exarro Matla Coal (Exarro) to conduct a Basic Assessment (BA) and Water Use License Application (WULA)/General Authorisation (GA) Process for the proposed upgrade of Sublime Access Road and the construction of the new intersection with R580 to provide access to the Exarro Coal Mine in Matla, Mpumalanga Province.

The EA Application is undertaken by means of a Basic Assessment Reporting (BAR) process in terms of the following Legislation:
