

60 DAY NOTICE PERIOD KHANYE COLLIERY: GRAVE IDENTIFICATION

CALLING INTERESTED AND/OR AFFECTED PARTIES (I&APs) IN ACCORDANCE WITH TERMS OF SECTION 35 & 36 (5) OF THE NATIONAL HERITAGE RESOURCES ACT (ACT 25 OF 1999)

GRAVES BACKGROUND

Khanye Colliery is an existing coal mine, owned by Oakleaf Investment Holdings 95 (Pty) Ltd, located approximately 5.5 km northeast of Bronkhorstspruit Town, within the City of Tshwane Metropolitan Municipality (CTMM), Ward 105, Gauteng Province. Situated within the proposed extent of the south pit of

Wagtenbietjieskop 506 JR Portion 75 is a burial ground which contains approximately 50 graves (see image below). G&A Heritage Properties (Pty) Ltd. has been appointed by Khanye Colliery to apply for a permit from the South African Heritage Resources Agency's (SAHRA) Graves and Burials Unit to identify these graves and their Next-of-Kin (NoK). The application will be made in terms of sections 35 & 36 (5) of the National Heritage Resources Act (NHRA) (No. 25 of 1999 and the 2000 Regulations), Section 2 (1) of the Removal of Graves and Dead Bodies Ordinance (No. 7 of 1925), the Exhumations Ordinance (No. 12 of 1980), the Human Tissues Act (No. 65 of 1983 as amended), as well as the relevant local regulations. For this permit, SAHRA requires an applicant to undertake a Public Participation Process (PPP), in order to identify and engage with any possible Interested and/or Affected Party (I&APs), grave owners, NoK and/or people who might be descendants of the deceased and obtain the required documentation as proof thereof. Subsequent to identifying the NoK, engagements will follow with each affected family/individual

to discuss the future management of the graves.

MEETING INFORMATION

Formal notice is herewith provided of four public meeting opportunities for any I&APs, NoK, or people who might be descendants of the deceased to assist with identification of the grave owners and discuss potential management options of the affected graves going forward. Any persons with any knowledge of these graves who wish to provide information in this regard are urged to attend at least one of these meetings. Due to the Covid Pandemic, we aim to limit each meeting to no more than 50 attendees, as such we will have a morning and afternoon session on the 29th and 31th of October, respectively.

Teargas, bullets fly in Eldorado Park riots

Four residents arrested for public violence

Members of the Eldorado Park community, south of Johannesburg, yesterday clashed violently with police as they were protesting the death of a 16-year-old disabled boy.

The teenager passed away on Wednesday night after allegedly being shot and killed by a police officer.

Community member Majiet Amien was disgusted by the incident.

"He was standing there innocently and they shot him at short range. It's wrong," Amien said. Public protection police responded to the mob with rubber bullets and teargas.

Members of the community attacked police officers with rocks and bottles. In one instance, live ammunition was fired at police officers, while they were sweeping a block of flats.

Gauteng SAPS head of communication Brig Mathapelo Peters said the Independent Police Investigative Directorate, the police watchdog, is investigating the incident.

Four community members were arrested for public violence, after at least three police officers were injured during the protest.

Three police vehicles were also damaged in the process.

Community members have vowed to continue protesting until police brutality in the area is addressed.

"If these people of SAPS do not come here now, we are going to do the same as what is happening in the United States," Amien said.

Parts of the US have seen violent protests this week following the shooting of 29-year-old African-American Jacob Blake, who was shot at the weekend in front of his three children who were in the car.

The much-publicised incident occurred in Kenosha, Wisconsin, on Sunday, as officers were attempting to arrest Blake over a domestic violence dispute.

Court bid for board's return fails

Sisulu fired nine of Umgeni Water board members

The Pietermaritzburg High Court this week dismissed with costs an urgent application by nine former Umgeni Water board members to have their terminations reversed. were terminated on July 31, had brought a motion before the court, seeking an urgent interdict.

"The judge did not see how the minister in exercising her legally empowered duties could cause irreparable harm to the former members," said Sisulu's spokesperson Yonela Diko.

Sisulu had said the reason for disbanding the board was because of the failure of previous minister Gugile Nkwinti to obtain cabinet approval before appointing the board.

In his ruling, judge Pieter Bezuidenhout said: "There is no irreparable harm if the interdict is not granted as the only issue is that of remuneration, which I have dealt with, and the balance of convenience, which is not in applicants' favour.

"I am satisfied that the applicants have failed to make out a case for the interim relief which is sought in the notice of motion." – TimesLIVE
