BASIC ASSESSMENT PROCESS FOR THE PROPOSED GATEWAY FUEL STATION & CONVENIENCE CENTRE, NORTHERN CAPE: NOTIFICATION OF PRE-APPLICATION COMMENTING PERIOD

HHH General Trading (Pty) Ltd, is proposing to develop a fuel station and related infrastructure on Erf 767 along National Route 18 (N18) in Jan Kempdorp, Phokwane Municipality, Northern Cape. This will, among other, involve the decommissioning of existing infrastructure on the site, and development of the existing old fuel station site, to accommodate modern and newly planned infrastructure and services.

Onyxia Environmental Management (OEM), on behalf of Fox Corporate Services (FCS) have been appointed to undertake the required Environmental Authorisation application process in terms of the National Environmental Management Act (No. 107 of 1998) (NEMA) and the Environmental Impact Assessment (EIA) Regulations of 2014, as amended. In terms of the EIA Regulations, the following Listed Activities have been triggered, necessitating the undertaking of a Basic Assessment process in terms of GN R982:
