RE: Availability of the FINAL SCOPING REPORT for the proposed Olien Solar (75MW) Facility Development, Prt 4 of Farm 300, Barkly West, Lime Acres, Northern Cape

Cape EAPrac have been appointed as the independent Environmental Assessment Practitioners, by the Applicant, AE-AMD Renewable Energy (Pty) Ltd., to ensure compliance with the regulations contained in the National Environmental Management Act (NEMA No 107 of 1998, as amended and including the 2010 Environmental Regulations) for the proposed development of the Olien Solar Facility on Portion 4 of Farm 300, Barkly West near Lime Acres in the Northern Cape. The procedures of a Scoping & Environmental Impact Reporting (S&EIR) environmental process, in terms of the 2010 Regulations, are being followed for this application.

Outcome of the Draft Scoping Report commenting period:

The Draft Scoping Report was available for a 40-day review and commenting period. This office would like to thank all parties that have submitted their comments on this application, providing important information for the next phase of the EIA process. All comments received during the 40-day comment period on the Draft Scoping Report (DSR) have been included in the FSR. The comments received, highlighted the following issues of concern:

- Waste management with regards to defective panels / end of panel lifespan;
- The development site falls within the Griqualand West Centre of Endemism;
- Occurrence of Verraux eagle on the Ghaap Plateau;
- Cumulative ecological impact of the proposed development;
- Impact of cabling and lightning on migratory avifauna;
- Impact on ground dwelling species during the construction and decommissioning phases;
- Impact of the development on insect diversity;
- The microclimatic impacts of solar developments;
- More detailed assessment of the six pans identified on the site;
- The conservation importance and sensitivity of the Ghaap Plateau vegetation type;
- Protected tree, the Wild Olive, which occurs extensively and in high densities on the site;
- Presence of a number of vulnerable and near vulnerable bird species on the development site;
- The assessment of an alternative site is strongly advised;
- Biodiversity offsets will not be discussed before all alternative sites have been assessed and mitigations investigated; and

• EMP requirements including water pollution mitigation, health and safety of workers, social responsibility, fire risk and mitigation measures, waste disposal, and air pollution.

These issues have been highlighted in the Final Scoping Report, and preliminary responses have been provided. For some of the concerns raised, it will only be possible to address these concerns in full in the upcoming Environmental Impact Assessment phase of the EIA, as further specialist assessment and investigations will be undertaken during the next phase of the EAI.
