

**Proposed Activity:** FG Emvelo received Environmental Authorisation (EA) for the Karoshoek 400kV Grid Integration Project on 20 March 2013. The applicant is requesting the validity of the Environmental Authorisation (EA) and subsequent Amendments to be extended by an additional 10 years such that the EA would be valid for a period of twenty (20) years from the date of issue of the authorisation.

**Project Location:** The project is located on the following properties: Portion 0 of Farm Karos 959; P20ortion 3 of Farm Annashoek 41; Portion 0 of Farm Zandemm 944; Portion 2 Fram of Matjiesrivier 41; and Portion RE of Farm Matjiesrivier 41, within the Dawid Kruiper Local Municipality in the Northern Cape Province.

Amendment Process: In terms of Condition 5 of the EA (DFFE Ref: 14/12/16/3/3/2/288) dated 20 March 2013 and Regulation 29 of the EIA Regulations 2014, as amended, it is possible for an applicant to apply, in writing, to the competent authority for an amendment of the environmental authorisation if the amendment will not change the scope of a valid environmental authorisation nor increase the level or nature of the impact. An application in this regard has been submitted to the DFFE who have confirmed that the application falls within the ambit of a Part 1 amendment process. A public participation process is required to be undertaken in support of this application in accordance with the requirements of the DFFE.
