

**ENVIRONMENTAL AUTHORISATION APPLICATION: LOMOND SAFARI 88KV POWERLINE. EIA REFERENCE NO.: 2022-01-0005**

You are hereby informed of the proposed application for Environmental Authorisation for the Lomond Safari 88kV Powerline project. The application will be lodged with the National Department of Forestry, Fisheries and the Environment in terms of the NEMA, 1998 (Act No. 107 of 1998), as amended, and the EIA Regulations, 2014, as amended. The applicant, Eskom Holdings SOC Limited, has appointed Trans-Africa Projects, who have appointed MuTingati Environmental and Projects in terms of the EIA Regulations (GNR. 982 of 4 December 2014, as amended), as the independent Environmental Assessment Practitioner (EAP) for the application process.

**PROJECT DESCRIPTION:** -Construction of a 1 x 88kV chickadee powerline of ±2.3km from Lomond MTS to Safari Rural substation. Steel structures will be utilised to build the HV powerline. -Part of the 2 x 88kV underground oil filled cables will be dismantled and sealed off. -The Safari Rural substation will be refurbished by replacing old and redundant equipment.

**LOCATION:** Portion 0 of the Farm Weldaba 567 JQ, Madibeng Local Municipality, Bojanala Platinum District Municipality, North West Province. GPS coordinates: Starting point: 25° 48.141'S; 27° 56.315'E. End point: 25° 48.067'S; 27° 55.111'E.

**LEGISLATION:** The proposed project requires Environmental Authorisation and a Basic EIA process for the following listed activities in terms of the EIA Regulations, 2014, as amended: GNR. 983 of 4 December 2014 (Listing Notice 1), as amended: Activity No. 11; and GNR. 985 4 December 2014 (Listing Notice 3), as amended: Activity No. 12. The public participation processes are conducted according to the requirements of Chapter 6 of the EIA Regulations and the requirements of the Protection of Personal Information Act, 2013 (Act No. 14 of 2013).
