



Notice is hereby given in terms of Chapter 5 of the Environmental Impact Assessment Regulations (EIA), 2014 (as amended), Mational Environmental Management Act (Act No. 107 of 1998) that Eskom Holdings SOC Ltd intends to amend the Integrated Environmental Authorisation for the expansion of Kriel's Ash Øisposal Facility (ADF). In line with the NEMA EIA Regulations, Eskom Holdings SOC Ltd appointed GA Environment (Pty) Ltd as Independent Environmental Consultants to conduct a Part two anorndonent of the Integrated Environmental Authorisation (IEA), in terms of Regulation 31 of the EIA Regulations of 2014, as amended for the Kriel's Power Station's existing Ash Disposal Facility (ADF). The Kriel Power station is situated within the Emalahleni Local Municipality, approximately 7 km west from the town of Kriel. The site centre coordinates are 26°16′31.86″S;29°12″\ 88″E

Eskom/Krielis a coal fired power station which makes use of a wet ashing system to dispose of its ash. The ash is pumped to three existing ash dams, which will reach its rate of rise by the end of July 2021. It is one of the reasons that Eskom commissioned an Integrated Environmental Authorisation process. The Department of Environmental Affairs (DEA) issued an Environmental Authorisation on 30 March 2018 (12/12/16/3/3(372)). Condition 17.3.1 of the Environmental Authorisation indicates that Construction of the proposed ash disposal facility, pollution control dams and associated infrastructure shall ashere to class Charrier liner.

The levels of the Sulphate detected at the receptors are greater than the source term concentration of the ash dams, hence a no liner approach is preferred based on the low expected pollution load from the proposed extension of the ADF and the much higher existing pollution load in the area. It is Eskom's intention to therefore apply for a relaxation of condition 17)3.1 based on the outcome of the SPR and the costs implications of procuring a Class Cliner. Eskom proposes to install a Class D barrier liner with added aspects, e.g., Herringbone drains.
