NOTICE: PROPOSED MITIGATION OF HUMAN REMAINS AS PART OF THE WIDENING OF NATIONAL ROUTE 1 (HOLFONTEIN TO KROONSTAD)

Notice is hereby given that: PGS Heritage (Pty) Ltd and a local funeral undertaker intends applying in terms of Section 35 and 36 of the National Heritage Resources Act (Act 25 of 1999); and Regulations relating to the management of human remains as set-out by the National Health Act, 2003 (Act 61 of 2003), as well as the relevant local regulations; to the: Provincial Administration of the province in which the graves are located, the South African Heritage Resources Agency (SAHRA) or their legislated provincial agency and the relevant local municipality for approval to exhume and re-inter in a local cemetery the remains currently buried at this location.

1. Approximately 64 graves situated next to the N1 between Kroonstad and Bloemfontein at KM mark 40,040. The graves are located in the Road Reserve (previously a portion of the farm Deyselsdrif 1644). The coordinates of the cemetery are S27.741007 and E27.231595

The human remains will be exhumed from their current place of burial and reburied in a local municipal cemetery or at a new location as per the request of the deceased's families.

The proposed relocation of the remains is necessitated because of the planned widening of National Route 1 and the construction of an adjacent servitude road.

All persons and communities descendant from the buried individuals, all persons and communities by tradition concerned with the graves or any person or communities with an interest in the graves are invited to participate in the process and must forward their contact particulars to the address listed below within 14 days of the date of publication of this notice:
