### APPLICATION FOR AMENDMENT TO THE ENVIRONMENTAL AUTHORISATION: LICHTENBURG 1, LICHTENBURG 2 & LICHTENBURG 3 PV FACILITIES, NORTH WEST PROVINCE

### (DEA Refs: 14/12/16/3/3/2/1091, 14/12/16/3/3/2/1092 & 14/12/16/3/3/2/1093)

### NOTIFICATION OF AVAILABILITY OF THE MOTIVATION REPORT FOR REVIEW AND COMMENT

ABO Wind Lichtenburg 1 PV (Pty) Ltd, ABO Wind Lichtenburg 2 (Pty) Ltd and ABO Wind Lichtenburg 3 (Pty) Ltd received Environmental Authorisations (EAs) in July 2019 (DEA Ref. Nos. 14/12/16/3/3/2/1091, 14/12/16/3/3/2/1092 and 14/12/16/3/3/2/1093) for the development of solar energy facilities (including associated infrastructure) near Lichtenburg within the Ditsobotla Local Municipality and the Ngaka Modiri Molema District Municipality, Northern West Province. The development of the BESS for each of the solar energy facilities is based on the intention to bid the project as part of the Risk Mitigation Independent Power Producer (IPP) Procurement Programme and/or Renewable Energy Independent Power Producer Procurement Programme (REIPPPP) of the Department of Mineral Resources and Energy (DMRE) and/or any future relevant procurement programme. Ultimately, the development of the solar energy facilities as well as the battery energy storage is intended to be part of the renewable energy projects portfolio for South Africa, as contemplated in the Integrated Resources Plan (IRP). For solar energy to be dispatchable it will require the additional battery energy storage applied for in this amendment.

The proposed amendment includes the construction and operation of a Battery Energy Storage (BESS) for the authorised Lichtenburg 1, Lichtenburg 2 and Lichtenburg 3 facilities with a capacity of up to 500MW/500MWh into the project description of the Environmental Authorisations (EAs) of each of the solar energy facilities. The BESS will be developed within the development footprint, within the authorised laydown area of each of the PV facilities, and with an extent of no more than 5ha.

Taking the above into consideration, ABO Wind Lichtenburg 1 PV (Pty) Ltd, ABO Wind Lichtenburg 2 (Pty) Ltd and ABO Wind Lichtenburg 3 (Pty) Ltd is requesting the Department of Environment, Forestry and Fisheries (DEFF) to amend the project description of the EA (dated 01 July 2019, 02 July 2019 and 03 July 2019) as follows:

In terms of Condition 5 of the Environmental Authorisation dated 9 July 2014 and Regulation 31 of the EIA Regulations, 2014, as amended, it is possible for an applicant to apply, in writing, to the competent authority for a change or deviation from the project description to be approved.

In order to verify the potential for a change in the impacts on ecology and surface hydrology; avifauna; soils and agricultural potential; heritage; visual and social aspects as a result of the proposed amendment, specialist inputs into the amendment motivation reports have been included.

Savannah Environmental has prepared Motivation Reports in support of this Amendment Applications on behalf of the Applicants. The Motivation Reports are available for a 30-day review and comment period from Friday, 16 October 2020 to Monday, 16 November 2020 and can be downloaded from Savannah Environmental's website (<u>https://www.savannahsa.com/public-documents/energy-generation/</u>). The due date for written comment is Monday, 16 November 2020.

All comments received will be included in the final Motivation Report which will be submitted to the DEFF for review and decision-making.
