With reference to 1(f) please find attached the environmental screening tool as requested.



This letter serves to inform you that your Basic Assessment Report (BAR) has been evaluated by this office and found to be compliant with the minimum requirements of National Environmental Management Act, 1998 (as amended) (NEMA) and the Environmental Impact Assessment (EIA) Regulations, 2014, however the following issued need to be addressed.

a) The proposed financial provision quantum to the amount of R150 0002.00 as proposed by you was reviewed accepted.

b) Support your application with financial provision to the amount of R150 0002.00 which is in line with you proposed mining activities for the rehabilitation and /or management of negative environmental impacts. Kindly not that in terms of Section 24P (1) of the NEMA, 1998 (107 OF 1998) as amended, the requested amount should be provided either in a form of Bank guarantee or Cash deposit into DME Rehabilitation Trust account, account no. 40 6703 4181 (ABSA).

c) Provide interim and final comments from South African Heritage Resource Agency (SAHRA)

d) Provide comments from the Department of Water and Sanitation regarding the water use licence, since the depth of the boreholes might encroach underground water

e) Provide all relevant specialist studies triggered by the proposed prospecting activities.

f) Provide Environmental screening tool for the proposed area
