**AMENDMENT OF THE ENVIRONMENTAL AUTHORISATION ISSUED ON  
8 AUGUST 2014 FOR THE 75MW PV3 PHOTOVOLTAIC ENERGY FACILITY ON THE

**Notification of Amendment of the Environmental Authorisation**

Our correspondence of 12 May 2017 refers.

As noted in our correspondence of 12 May 2017, a typographic error relating to the affected property was made by the Department of Environmental Affairs (DEA) in the project title of the previous Amendment to the Environmental Authorisation, dated 3 May 2017. Klipgats Solar PV3 (Pty) Ltd submitted a letter to DEA on 12 May 2017, requesting that the error be corrected. DEA have referred to the aforementioned letter requesting the correction of the error as an "Application for Amendment of the Environmental Authorisation (EA)".

This letter serves to notify all registered Interested and Affected Parties (I&APs) of DEA's decision in respect of the Application for Amendment of the Environmental Authorisation issued on 8 August 2014 for the proposed 75MW PV3 Photovoltaic (solar) energy facility on Remainder of Portion 4 of Farm Klipgats Pan No. 117 within the Siyathemba Local Municipality near Copperton, Northern Cape Province. Furthermore, the provisions regarding the submission of appeals that are contained in the National Environmental Management Act (NEMA) (No. 107 of 1998) Environmental Impact Assessment (EIA) Regulations (2014), as amended, are also outlined herein, should an I&AP wish to appeal DEA's decision.

**1. Decision**

We wish to inform you that, based on a review of the reason submitted by Klipgats Solar PV3 (Pty) Ltd for requesting an amendment to the abovementioned Environmental Authorisation (EA) (i.e. correction of the typographic error in the project title of the amendment EA dated 3 May 2017), the

DEA, in terms of Chapter 5 of the EIA Regulations, 2014 **has decided to amend the EA dated 8 August 2014**, as follows:

**Correction of the project title of the EA amendment dated 3 May 2017:**

**From:**

*"The proposed 75 MW PV3 Photovoltaic Energy Facility on the Remainder of Portion 4 of the Farm Klipgats Pan No. 177, near Copperton, situated within the Siyathemba Local Municipality Northern Cape Province."*

**To:**

*"The proposed 75 MW PV3 Photovoltaic Energy Facility on the Remainder of Portion 4 of the Farm Klipgats Pan No. 117, near Copperton, situated within the Siyathemba Local Municipality Northern Cape Province."*

DEA's amendment to the EA is included in Annexure A herewith for your information<sup>1</sup>.

## 2 Right to appeal

We would like to draw your attention to your right to appeal against the decision to the Minister in terms of the National Appeal Regulations (Government Notice No. R993) of the NEMA EIA Regulations (2014), as amended, which prescribes the appeal procedure to be followed.

Should any person wish to lodge an appeal, the appellant must submit an appeal to the appeal administrator, and a copy of the appeal to the Applicant (i.e. Klippgats Solar PV3 (Pty) Ltd), any registered Interested and Affected Party, and any organ of state with interest in the matter within 20 days from the date<sup>2</sup> that the notification of the decision was sent to the Applicant by DEA.

### **Kennisgewing van die Wysiging van die Omgewingsmagtiging**

Ons korrespondensie van 12 Mei 2017, verwys.

Soos genoteer in ons korrespondensie van 12 Mei 2017, is 'n tipografiese fout gemaak deur die Departement van Omgewingsake (DOS) rakende die geaffekteerde eiendom in die projek titel van die vorige Wysiging van die Omgewingsmagtiging, gedateer 3 Mei 2017. Klippats Solar PV3 (Edms) Bpk het 'n brief aan DOS gestuur op 12 Mei 2017, wat versoek het dat die fout reggestel moet word. DOS het verwys na die brief en versoek dat die regstelling van die fout 'n "Aansoek vir Wysiging van die Omgewingsmagtiging (OM)" moet wees.

Die doel van hierdie brief is om alle geregistreerde Belanghebbende en Geaffekteerde Partye (B&GPe) in te lig oor die DOS se besluit rakende die Aansoek vir die Wysiging van 'n Omgewingsmagtiging wat op 8 Augustus 2014 uitgereik is vir die voorgestelde 75MW PV3 Fotovoltaïese (son) energie-aanleg op die Restant van Gedeelte 4 van die Plaas Klippats Pan Nr. 117 binne die Siyathemba Plaaslike Munisipaliteit naby Copperton, Noord-Kaapprovinsie. Die riglyne vir die indiening van 'n appèl, soos uiteengesit in die Wet op Nasionale Omgewingsbestuur (NEMA) (Nr 107 van 1998) se Regulasies (2014), soos gewysig, vir Omgewingsinvloedbepalings (OIB), word ook hierby ingesluit indien 'n B&GP teen die DOS se besluit wil appelleer.

### **1. Besluit**
