NOTICE OF AN APPLICATION IN TERMS OF SECTION 16 OF THE MINERALS AND PETROLEUM RESOURCES DEVELOPMENT ACT, 2002 (ACT NO 28 OF 2002) AND THE NATIONAL ENVIRONMENTAL MANAGEMENT ACT, 1998 (ACT NO 107 OF 1998 NEMA) AS WELL AS THE ENVIRONMENTAL IMPACT ASSESSMENT REGULATIONS OF 2014 (AS AMENDED BY GNR 326 EFFECTIVE 7 APRIL 2017).

An application for a prospecting right in terms of Section 16 of the Mineral and Petroleum Resources Development Act, 2002 (Act No. 28 of 2002) [MPRDA] has been submitted to the Department of Mineral Resources (DMR). The proposed project triggers the following listed activities in terms of the National Environmental Management Act, 1998 (Act No.107 of 1998) [NEMA] and the Environmental Impact Assessment (EIA) Regulations (as amended by GNR 326 effective 7 April 2017), and therefore requires a basic assessment process to obtain environmental authorisation.

The Basic Assessment Report and Environmental Management Programme are the legal requirement for all prospecting activities and have to be approved by the Department of Mineral Resources (DMR).


2. Project description and Location

- Geophysical and geochemical surveys; and/or drilling. •


