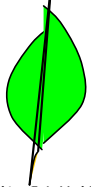

GRANTING OF THE ENVIRONMENTAL AUTHORISATION

PROPOSED UPGRADING OF THE CALVINIA WASTEWATER TREATMENT WORKS IN THE NORTHERN CAPE

1. Please be advised that the Department of Environment and Nature Conservation(DENC) has granted a permit, dated 26 April 2012, to the Hantam Local Municipality for the proposed upgrading of the Calvinia Wastewater Treatment Works as well as its associated infrastructure, at Erf 3436, Calvinia. This was done in terms of the National Environmental Management Act, 1998 (Act 107 of 1998).
2. A copy of the permit will be furnished upon request.
3. According to Chapter 7 Section 62, of GN No. R 543 of 18 June 2010 in terms of the National Environmental Management Act, 1998 (Act 107 of 1998) as amended, any person wishing to appeal against any aspect of the decision must submit a notice of intention to appeal Member of the Executive Council within twenty (20) days of the date of the decision, and an appeal must be lodged within thirty (30) days after the lapsing of the 20 days contemplated in regulation 60 (1) of lodging of the notice to appeal..


